Paul Maher, Project Manager, Halifax Transit Services gave a presentation for the purpose of receiving feedback and responded to questions of clarification from the Committee.

The Committee noted the following:

• Inconsistencies between decreased service levels on weekends despite increased ridership;

Draft Minutes September 4, 2025

- Efforts and challenges in providing transit services to low density areas;
- The need to guarantee that buses arrive on schedule;
- Safety concerns for women and gender diverse individuals during service delays;
- The safety of women and gender diverse individuals when riding buses at night;
- Barriers to reporting incidents occurring on buses including the lack of awareness that incidents can be reported to 311;
- The possibility of adding signage indicating that issues and incidents can be reported to 311 on all buses:
- The importance of breaking down the silos and ensuring collaboration among the departments of Halifax Transit;
- Accessibility issues with bus passengers needing to squeeze behind the yellow near the driver;
- Halifax Transit remaining open to approaching challenges differently;
- Concerns with overcrowding on express routes;
- Residents moving outside of the downtown core due to housing affordability and the subsequent impacts to ridership on weekends;
- Holding future pop-up engagements on university campuses;
- Challenges faced by student populations when accessing and using transit;
- Misinformation being provided to discharged hospital patients regarding the ability to use transit services to get to future appointments;
- Methods to engage and appeal to residents within the urban service boundary who do not currently use transit;
- Increasing transit use to get cars off the road and lower traffic congestion;
- The benefits of the former Route 52 that provided service from Morris Street to Bayers Lake;
- The need to ensure safety is an integral component of the Halifax Transit Core Services Plan;
- The possibility of providing free transit services which would require support from all levels of government;
- The importance of exploring new ways to tackling longstanding issues;
- Issues with providing bus passes to high school students that live in areas where they cannot access transit; and
- The benefits of moving to a model where transit engagement is conducted more frequently.

Maher noted they would share data with the Committee regarding the rate of violence incidents occurring on Halifax Transit buses.

Reference was made to the presentation delivered at the October 1, 2025 Board of Police Commissioners meeting regarding violence occurring on Halifax Transit buses which would be provided to the Committee for information.
