Group 3: North American Indigenous Games 2020 More awareness around Indigenous youth holistic health

Group 4: Bringing more interest and accessibility to education Environmental issues / racism Climate change awareness Recycling Supporting youth initiatives acting on environmental issues (e.g. iMatter Enrich Project) Engaging underprivileged communities; education

Group 5: Accessibility to buildings Accessibility: built space, transit Queer spaces Alternatives for single-use plastics

Group 6: Mental health outlet for men / end the stigma Mental health support Mental health services, particularly for high school & university students
