11.3.1 Shore Active Transportation Association (SATA) – Patricia Richards, Chairperson

The following was before the Community Council:

A slideshow presentation from the Shore Active Transportation Association

Ms. Patricia Richards, Chairperson of SATA, provided a slideshow presentation outlining the Active Transportation Plan for Porter's Lake and the Surrounding Communities. As she explained, the recommendations are to develop AT Greenways & link them, pave shoulders to key routes, develop AT supporting infrastructure, and increase AT awareness in the area. Ms. Richards outlined a number of the SATA's accomplishments and informed the Community Council that they are looking for assistance with the Acadian March Trail and Gaetz Brook Connector through collaboration between HRM and the Province as well as assistance with paved shoulders, the Blue Route, and a continuation of work on the priorities laid out in the AT plan for the area.

Members of the Community Council commented on the importance of the project and thanked Ms. Richards for the presentation.

20. PUBLIC PARTICIPATION

The Chair opened the floor for public participation.

Mr. Kent Smith of the Musquodobit Harbour Area Chamber of Commerce and Civic Affairs (MHACCCA) thanked the Community Council for moving the request for a staff report on to Regional Council and explained that the partial funding sought by the MHACCCA is primarily intended for recreation.

Mr. Warren Wesson of Dartmouth commented that the branding exercise is an example of why there is voter apathy in HRM and spoke to his pride for his community.

Ms. Elizabeth Campbell discussed the negative effects of the rebranding project on community identity and expressed frustration with the lack of results despite the number of citizens opposed to the rebranding. She distributed a written copy of her comments to the Community Council.

Mr. Victor Matthews of Dartmouth spoke to the size of the Dartmouth Community and the need for signs that designate the community. He distributed a written copy of his comments to the Community Council.

Ms. Barb Killen commented that, after three years, she is still waiting to find out what is going on with the sale of her property on Cole Harbour Road. She informed the Community Council that she is under the impression that the contractors have fulfilled all of their duties.

Mr. Colin May, Dartmouth, commented that he came across a document outlining performance based pay information on the Halifax.ca website and questioned how this would relate to planning staff.
