Mr. Doug Brownrigg, Chair of the Canal Greenway Committee and Mr. Bill McIntyre, Chair of the Shubenacadie Canal Commission gave a presentation on the Historical Shubenacadie Canal Greenway Park project. A copy of the presentation is on file.

Mr. Brownrigg and Mr. McIntryre responded to questions around the site plan and phasing. The following points were noted:

- the displays will be manned by volunteers during summer months but not full time; the layout of building will have lots of windows so people can see in year-round; the turbine will be on display and small tours will be offered
- the grand opening is projected for mid-September 2017
- landscaping should be 90 percent if not fully completed by September 2017
- Halifax Water is responsible for the water feature near Sullivan's Pond; date of completion is unknown

- 5. Requiring all parking areas to be paved.

#### 18. PUBLIC PARTICIPATION

Charlie Burnette, Dartmouth commended the Shubenacadie Canal Commission Greenway Committee for their excellent work but questioned the absence of children's play area at the north end near the Esso station in the artist's rendering that had always been a provision for in the plan.

Warren, District 5 agreed with Charlie Burnette's comments and the need for a play area in the area and suggested that one of the three sports pads could be used as a modular waiting pool and play area in the summer. Warren recognized Councillor Hendsbee's county flag on display in the HEMDCC meeting space and spoke about renaming the Alderney Public Library to the Dartmouth Central branch.

Liz Campbell, Dartmouth East circulated a handout from the Halifax.ca website and asked if a decision was made to change the name on the site from Halifax Regional Municipality to HRM to just Halifax. She expressed concern with businesses and organizations referring to all locations in the Municipality as Halifax.

David Jones, Downtown Dartmouth spoke on the history of the Starr Manufacturing Company in Dartmouth and its legacy with the Shubenacadie River. He was concerned with Starr being an after through and asked how it would be incorporate into the Canal Greenway project, suggesting that the plaque made for the Starr site be attached to a replica of a Starr skate and displayed at the Canal Greenway.
