# 10.2.1 Case 21137: Appeal of Variance Approval - PID No. 41074493, Rocky Lake Drive, Bedford

Sean Audas, Development Officer provided a presentation with respect to Case 21137.

In response to questions of clarification, Audas advised that the applicant will need to meet all specifications in the lot grading By-law with respect to protecting a nearby watercourse and wetlands.
