A MESSAGE FROM COUNCILLOR STEELE

Happy January, District 12! I want to wish everyone a very happy new year and prosperous 2025. I hope you were able to take some well-deserved time with family and friends.

The Volunteer Award nomination period has been extended to Sunday January 12 at midnight. Details on the nomination process and submission can be found here. I encourage you to nominate anyone you feel is an outstanding volunteer in our community.

As we move into January, Regional Council will begin the 2025/26 budget discussion. Further details on this process can be found below in this newsletter.

At the January 15 Board of Police Commissioners (BoPC) meeting, there is a request that the BoPC recommend that the HRM Budget Committee support the Royal Canadian Mounted Police Halifax Regional Detachment (RCMP HRD) to acquire an additional fourteen regular member positions as part of the budget deliberations for the 2025-2026 operating budget. This would include a community office in Beechville with six positions.

According to HRD, a satellite office in the community of Beechville is needed to support the effective and efficient delivery of core policing services in those areas, but more importantly reflect the direct feedback HRD has received from its community and stakeholder consultations.

WINTER OPERATIONS

December 20-21 and December 24-25 brought our first two major snow events of the winter season. Around these events, I received many calls and emails from the BLT communities expressing concern with the quality of the snow clearing and in some cases the lack of adequate salt. As follow-up, I have met with the HRM Winter Operations management team, and they will be monitoring this area closely to ensure that the performance-based contract is being respected. HRM staff have assured me that during storms they have supervisors out monitoring the quality of work and that the contractor has a patroller available 24 hours a day with a truck that has a plow and salt.


According to staff, the most effective and efficient way for snow and ice issues to be addressed is for residents to call 311 directly or email at contactus@311.halifax.ca. Agents can have HRM supervisors investigate and follow up directly. I am hopeful the first two snowfalls permitted new operators to gain experience and that we will have better outcomes over the rest of the season.

Residents should only call 311 after the service period has elapsed. To find out the service priority of your street, <u>click here</u>.

A few additional points to note:

Some callers were concerned with parked cars impeding snow removal efforts. It is up to all of us to be aware of when there is a winter parking ban and to ensure vehicles are not impeding snow removal efforts and making it inconvenient for other residents. You can sign up to receive information on the winter parking ban here.

HRM will be contracting a third-party review of winter operations in 2025. This type of third-party review is carried out every five years.

St. Margaret's Bay Road Construction

We want to thank the residents for their patience as we completed some important projects in the St. Margaret's Bay Road area, I know there were major inconveniences especially close to the holiday season.

The following is an update on what has been completed and the future projects still required:

Completed Projects:

- Sidewalks from Raines Mill Road to Beechville Park Drive
- New bus stop located beside 1399 St.
 Margarets Bay Road
- Paving and concrete work on Brentwood Avenue and Maplewood Drive
- The Beechville Lakeside Timberlea Trail between Brentwood and Maplewood has been paved and trees have been planted along the realigned trail embankment
- Landscaping has been completed around Fitzgerald's Grocery,
- Paving and trench work across the road from the Lakeside Community Centre

2025 Projects:

- Additional sidewalk into Oliver Street in Monroe Subdivision
- Two new crosswalks with Rectangular Rapid Flashing Beacons lights on St.
 Margarets Bay Road at Oliver Street and Raines Mill Road are to be installed as soon as possible as pavement markings are temperature dependent.
- Guide rail and fencing along the Brentwood trail will to be completed in January 2025.
- Munroe Subdivision will not be receiving paving this year, but the current gravel pathways are to be upgraded to paved pathways for all three access points, including the right of way next to 21 Oliver to Munroe Park Playground.

CLAYTON PARK, WEDGEWOOD COMMUNITY CORNER

Construction on Parkland Drive

I have received many inquiries regarding the work on the property across from 767 Parkland Drive. Staff have confirmed there is a permit application for a Single Unit Dwelling at this site, however the permit is incomplete and has not been reviewed by a Planner or Building Official yet. Updates on the status of the permit can be viewed on HRM Open Data here. It is clear other activity is taking place on this property and a Municipal Compliance case has been opened to investigate. Staff are in communication with the property owner to have the use occurring on the site addressed to be in compliance with the by-law. While a compliance investigation is ongoing, staff are unable to provide further details. I will continue to provide updates as they become available.

Thomas Raddall Drive Shelter Village Update

The Nova Scotia Department of Opportunities and Social Development (formerly the Provincial Department of Community Services) construction of the Shelter Village at Thomas Raddall Drive is nearing completion, and some residents have moved in. We are expecting the Province to announce the official opening of this site very soon.

EV Chargers at the Canada Games Centre

The four new Level 2 EV chargers at the Canada Games Centre parking lot are now open! The Level 3 charger is not yet open but it should be soon.

There are user fees for public EV charging stations that are owned and operated by the municipality. The fees are set at \$0.03 per minute for Level 2 charging and \$0.75 per minute for Level 3 charging and were designed to cover ongoing fixed and variable operational costs of the chargers.

2025/26 MUNICIPAL BUDGET

Halifax Regional Council has begun the process of reviewing the municipal budget for the 2025/26 fiscal year.

The municipal budget funds all costs associated with servicing our growing municipality including day-to-day municipal operations, capital projects and more.

Residents are encouraged to check out these meetings, you can even have the opportunity to speak directly to the Budget Committee during the public participation portion of each meeting:

Budget Introduction and Capital Plan Recommendation - Wednesday, February 5

High level discussion of the starting point for the 2025/26 municipal budget.

Business Unit and Budget Presentations - Wednesday, February 12 to Wednesday, February 26

Each municipal business unit, including police, public works, transit and much more will present their proposed budget and business plan for discussion. Full schedule can be found here.

Budget Adjustment List (BAL) Review - Wednesday, March 19

Reviewing all additional items that business units have presented beyond their proposed budgets, including add-ons ("overs") and subtractions ("unders").

Final Budget Approval - Tuesday, April 8

APPLICATIONS OPEN FOR COMMUNITY GRANTS PROGRAM

The Halifax Regional Municipality is advising eligible registered non-profit and charitable organizations that applications for the Community Grants Program have opened.

The program provides annual cash grants to registered non-profit organizations and charities located throughout the region. There are two grants available – a project grant of up to \$5,000 or a capital grant of up to \$25,000.

The program has seven funding categories, which include the following: community arts; diversity and accessibility; environment and climate change; emergency assistance and neighbourhood safety; community histories; leisure; and recreation. Applicants must indicate the category which best matches the funding category.

Applicants should review the <u>2025/26 Program</u> <u>Guidebook</u> prior to applying, and first-time applicants are encouraged to contact municipal staff prior to submitting an application.

311 MUNICIPAL SERVICES AND INFORMATION

For routine municipal matters such as reporting potholes, snow clearing, requesting traffic calming assessments, garbage collection and much more, please call 311 or email at contactus@311.halifax.ca. Please feel free to copy me on your email if this not a routine matter.

When you call 311, your request is logged and tracked to ensure follow up and action by the appropriate department. Please be sure to advise the agent if you would like to receive a follow up from staff regarding your service request.

More than a telephone number, 311 is your direct connection to important municipal services and information. There are three customer service centre locations in the Halifax region. You can also contact 311 by phone, regular mail, online service requests, or email.

PROPERTY TAX ASSESSMENT APPEALS

Property Valuation Services Corporation (PVSC) assesses every property in Nova Scotia and mails over 638,000 Property Assessment Notices to property owners every January. If you are a property owner, you should be receiving your latest Property Assessment Notice in the coming weeks.

There is an option to appeal/refute your assessment within 31 days of the date on your Assessment Notice.

INFRASTRUCTURE GRANTS FOR COMMUNITY GROUPS

Applications for the Department of Communities, Culture, Tourism, and Heritage's (CCTH) Community Infrastructure, Active Transportation, and Access-Ability grants for the fiscal year 2025-26 are now open until February 14. This is an important opportunity for local organizations and entities to enhance and improve community facilities and help to support a more accessible and vibrant future for everyone.

There are grants available for renovations to community halls, recreation facilities, rinks and legions, accessibility improvements for businesses and community centres, and active transportation projects that link communities.

To apply, groups must be registered non-profit societies, Mi'kmaw Band Councils, municipalities and villages and schools with facilities available for community recreational use.

Potential applicants can discuss their projects with a CCTH regional manager or program officer before submitting an application to ensure that you are best positioned to succeed in securing the support you need. ICE SAFETY

The municipality is no longer conducting ice thickness testing as changing climate patterns, including rapidly fluctuating temperatures, have made ice thickness testing no longer feasible or reliable.



DISPOSING OF YOUR CHRISTMAS TREE

You can dispose of natural Christmas trees by placing them curbside on your regular green cart collection day. Natural Christmas trees picked up from the curb are processed into mulch for landscaping.

Please remove all plastic, tinsel, ornaments, metal rings, nails, stands and plastic tree bags before disposing of your tree.

TAX RELIEF FOR NON-PROFIT ORGANIZATIONS

The Municipality's Tax Relief for Non-Profit Organizations Program for registered non-profit and Canadian charitable organizations located within the region is open until January 31.

This program can help eligible non-profit and charitable organizations reduce the amount of property tax they pay each year.
