

## SPEEDS REDUCTION FROM MILL COVE TO FAIRVIEW OVERPASS



The speed limit on a large section of the Bedford Highway has been reduced from 60 km/h to 50 km/h. Signs identifying the reduced speed zones have gone up between Southgate Drive and Tremont Drive as well as between Sherbrooke Drive and the Fairview Overpass.

The reduced speed zones include Mount Saint Vincent University and numerous businesses. This change is related to the increase in residential and commercial development along the Bedford Highway, along with the related increase in vehicle, pedestrian and cycling traffic. In HRM, about 1 in 5 people live in a household that has trouble getting food on the table. HRM's food insecurity rate is higher than the national average.

The JUSTFood plan is aimed at helping more HRM residents get the healthy food they need. The plan was developed by HRM, Nova Scotia Health, Dalhousie University, the Ecology Action Centre and other partners. It recommends establishing the Halifax Food Council to set up social supermarkets (to provide healthy, discounted food) and circular food hubs (to divert and use food that might otherwise have gone to waste).

There are also plans to set up a community orchard and expand community gardens.

#### TACKLING THE HOUSING SHORTAGE



Regional Council is looking at ways to tackle the housing shortage in HRM. This spring, Council will vote on a package of zoning changes aimed at speeding up housing construction across the municipality.

Dozens of sites are being considered. Priority will be given to multi-unit housing proposed near universities, on bus routes and near existing services.

Five multi-unit housing projects are proposed in District 10: 70 Lacewood Drive, 167 Willett Street, 127 Harlington Crescent, 1 Lodge Drive and 44-48 Main Avenue. They are part of a package of projects coming to Regional Council under the Housing Accelerator Fund (HAF) agreement, a national program aimed at increasing housing supply.

As part of the HAF, it is also proposed to allow 4 units of housing on residential lots in suburban areas, up from 3 units currently permitted. The definition of units includes basement apartments, garage conversions or backyard suites. This is aimed at adding more affordable housing. Housing projects of 4 units will have more stringent setback and building code requirements than those involving 3 units.

If approved, HAF projects would receive new zoning which would allow them to move forward quickly. In suburban areas like ours, the zoning has not been updated for more than 40 years and a full rezoning February 2024 for all suburban areas is a few years away. Projects approved under the Housing Accelerator Fund could therefore get a head start.

A report on the HAF projects will come to Regional Council in March or April and a public hearing will be held at that time. In the meantime, I welcome any questions at <u>Kathryn.morse@halifax.ca</u>. For more about the Housing Accelerator Fund projects, visit our <u>website</u>.

#### **NEW SIDEWALKS COMING**

More transportation news! Regional Council has instructed municipal staff to proceed with the plan to construct approximately 55 kilometers of new sidewalks on high-need streets within the urban tax boundary over the next decade. This initiative aims to address the issue of many streets lacking sidewalks, forcing pedestrians to walk on sod, gravel shoulders, or in the street. Filling in these gaps is crucial for municipal planning, road safety, climate change mitigation, and accessibility.

This directive ensures that sufficient resources are allocated for Public Works to plan, design, construct, and maintain this infrastructure. Building new sidewalks within the urban tax boundary is a key component of HRM's Roads and Active Transportation capital budget. The funding for this work will be sourced from the existing budget and other potential cost-sharing opportunities.

Moving forward, staff will continue to use an evaluation tool to identify streets with the highest need for new sidewalks, with a particular emphasis on stand-alone projects on major roads. This proactive approach demonstrates HRM's commitment to enhancing pedestrian infrastructure and ensuring safer and more accessible streets for

#### WINTER PET CARE TIPS



As temperatures remain frigid, Halifax Regional Police wants to ensure that pet owners are taking extra precautions to keep their furry friends safe and warm. Here are some essential tips to help protect Fluffy and Fido during this cold weather season:

- Avoid leaving pets in cold cars: a cold car can be dangerous for pets.
- Keep pets indoors: Even though pets have fur, cold temperatures can still pose a risk to their health. It's best to keep them indoors, both during the day and at night.
- Provide a draft-free shelter: If your pets must stay outside, ensure they have a shelter that is large enough for them to move comfortably in and retain body heat. Use materials like straw or blankets for insulation and position the entrance away from wind and snow.
- Stay with pets during bathroom breaks: When taking your pets outside, be sure to accompany them. If it's too cold for you, it's too cold for them. Head back indoors promptly.
- Exercise caution around frozen bodies of water: thin ice on lakes, ponds, and rivers may not support your weight or that of your pet. Be extra cautious when near these areas.

## ICE THICKNESS TESTING PROGRAM NO LONGER BEING CONDUCTED



Over the last number of years, there has been a decline in the number of days available for skating. Based on these changed climate patterns, including rapidly fluctuating temperatures, ice thickness testing is no longer feasible. For this reason, the Halifax Regional Municipality is advising residents that it will no longer conduct the ice thickness testing program.

We realize that some residents may wish to continue skating on lakes, and there may occasionally be times when it is safe to do so.

Residents are asked to take safety precautions for themselves and their families by avoiding any further recreation activities on frozen lakes and ponds, including walking, snowmobiling, and skating.

The Canadian Red Cross recommends that ice be at least 15 cm thick for individual skating, and at least 20 cm thick for group skating. Extreme caution is advised in areas where streams flow into and out of lakes. It is also important to note that ice conditions may vary over the entire surface of lakes and are subject to change with weather conditions.
