HOUSING ACCELERATOR FUND

The Halifax region is experiencing an urgent housing shortage.

High interest rates, rapid population growth and supply shortages have contributed to this lack of housing.



As part of the <u>Housing Accelerator Fund</u>, the municipality is collaborating with partners and other levels of government in a national effort to support housing. The municipality is proposing updates to planning policies to enable more density and flexible housing types in residential areas. Public feedback on the proposed changes can be provided until February 16th.

OVERNIGHT PARKING BAN



The Halifax Regional Municipality is advising residents that the overnight winter parking ban will be enforced from 1 to 6 a.m. (in both Zone 1 – Central and Zone 2 – Non-Central), to allow crews to properly clear

streets and sidewalks.

Residents are able to determine which zone they're in by searching their address using the interactive tool available <u>here.</u>

Vehicles must be parked off municipal streets during the hours noted above. Regardless of the status of an overnight winter parking ban, or whether you have received a notification, vehicles can be towed, day or night, at any time of year, if they are interfering with snow-clearing operations, as per Section 139 of the <u>Nova</u> <u>Scotia Motor Vehicle Act.</u>

The overnight winter parking ban is in effect from now until Mar. 31, 2024. The easiest way to stay informed is to register for automated notifications by signing up for hfxALERT, checking halifax.ca/snow for updates, or by calling 311. Subscribers to hfxALERT will receive timely alerts by phone, email, and/or text message when the ban is in effect and again when it is lifted. Standard text messaging rates apply.

Vehicles obstructing a driveway or sidewalk are prone to damage and become dangerous for crews. Such obstacles prevent crews from clearing the sidewalks properly, which can quickly become an accessibility issue for pedestrians, seniors, people with mobility issues and parents pushing strollers.

Think before you park this winter - it will help make the season a little easier on everyone.

Do Your Part

Planters, lawn decorations and any other portable objects near the sidewalk should be removed before the winter. Any permanent structures or objects too big to move should be marked with a reflector that will be visible above the snow to help crews identify obstacles.

Never clear snow from your property onto the street or sidewalk. Property owners must ensure the snow they clear is piled on their own property. It is against <u>By-Law S-300</u> to throw or pile snow in the street or on the sidewalk. This is a serious problem that can cause safety issues as it complicates clearing. The municipality has <u>enforcement tools</u> in place to address non-compliance with the by-law.

ICE THICKNESS TESTING DISCONTINUED

The Halifax Regional Municipality is advising residents that it will no longer conduct the <u>ice</u> thickness testing program.

Over the last number of years, there has been a decline in the number of days available for skating. Based on these changed climate patterns, including rapidly fluctuating temperatures, ice thickness testing is no longer feasible.

We realize that some residents may wish to continue skating on lakes, and there may occasionally be times when it is safe to do so. Residents are asked to take safety precautions for themselves and their families by avoiding any further recreation activities on frozen lakes and ponds, including walking, snowmobiling, and skating.

Residents are reminded that the Canadian Red Cross recommends that ice be at least 15 cm thick for individual skating, and at least 20 cm thick for group skating. Extreme caution is advised in areas where streams flow into and out of lakes. It is also important to note that ice conditions may vary over the entire surface of lakes and are subject to change with weather conditions. MUNICIPALITY COMPLETES DISTRICT BOUNDARY REVIEW

The Halifax Regional Municipality has completed the District Boundary Review and

unveiled new electoral district boundaries. These updated electoral district boundaries will be used for the 2024 Municipal and Counseil scolaire acadien provincial (CSAP) Election. The <u>Municipal Government Act</u> requires that all municipalities in Nova Scotia regularly review the number and boundaries of electoral districts in the municipality. Following two phases of public engagement, the <u>Nova Scotia Utility and</u> <u>Review Board (NSUARB)</u> released their <u>boundary review decision</u> on December 21st, 2023.

RURAL RECREATION STRATEGY



On January 9, 2024, Regional Council approved the Rural Recreation Strategy. The

strategy demonstrates a meaningful shift away from applying urban

solutions to rural challenges. Designed to reflect and respond to the unique and evolving rural experience, it outlines six common themes based on the priorities identified in our public engagement. These include:

- 1) equitable access to indoor facilities;
- 2) access to outdoor recreation opportunities;
- 3) volunteer support;
- 4) programming that meets rural needs;

5) interdepartmental and inter-governmental partnerships; and

6) advertising and communications that reflect rural communities.

The strategy also identifies 60 actions for the short and longer term to improve access to enhanced services, while prioritizing

accessibility, inclusivity, and engagement for the next three years and there will be an update to Regional Council within one year.
