FRANOPHONIE MONTH



March is Francophonie Month, celebrating the French language and diverse Francophone cultures through cultural activities held worldwide.

March 20 has been observed worldwide as International Francophonie Day since 1988. The date commemorates the establishment of the Agence de Coopération Culturelle et Technique, the precursor to the <u>International Organization</u> of La Francophonie, the organization representing countries and regions where French is the first or customary language. Today, with 300 million speakers worldwide, French is the fifth most spoken language in the world; La Francophonie has 88 member states and governments.

NORTH WEST COMMUNITY COUNCIL

The North West Community Council met on February 26th, 2024 where the following items were discussed:

<u>Case VAR-2023-01314: Appeal of Variance</u> <u>Approval – Civic 15 Shankel Road, Hubbards</u> Halifax Planning staff gave a presentation and responded to questions of clarification from the Community Council regarding the appeal of an approval to a variance of the land-use bylaw. This variance would allow an existing deck within the front yard of the property at 15

Shankel Road. The appeal was defeated. Planning staff noted that the property owner would have had the option to appeal the decision to the Nova Scotia Utility and Review Board.

PLANAPP 2023-01145: Amending Development Agreement for 644 Bedford Highway, Halifax

A staff report was presented to the Community Council on the proposed changes to the current development agreement at 644 Bedford Highway to allow for a new development on the property. Community Council approved the motion to consider allowing the conversion of an interior parking area into two additional residential units.

PLANAPP 2023-00912: Development Agreement to Allow an Expansion to an Existing Recycling Depot at 15 Sackville Cross Road, Lower Sackville

The Community Council was asked to consider the proposed development agreement to allow for the expansion of an existing recycling depot in Lower Sackville. The committee approved the motion and a public hearing will be scheduled for a later date.

Bedford Land Use By-Law Amendment

During the meeting Councillor Outhit asked for a review of the Bedfored Land Use By-Law to allow for doggy day cares in the light industrial zone. The Community Council has directed the CAO to have staff produce a report.

2024-2025 BUDGET AND MULTI-YEAR CAPITAL PLAN APPROVED BY REGIONAL COUNCIL

Regional Council has approved the 2024/25 Capital Budget and the 2024/25 Multi-Year Capital Plan, which are the basis for staff's planning and resourcing preparations required to implement capital projects within the current year and next three years. The Operational budget is still under review, as we examine each departments proposed operations budget.

Some key projects in the Capital budget include the Beechville Lakeside Timberlea Recreation Centre recapitalization, new Halifax Regional Fire & Emergency (HRFE) Headquarters and Fire Station on Hammonds Plains Road, active transportation and sidewalk recapitalization, HRFE fleet replacement, electric bus procurement and municipal building retrofits as part of HalifACT.

SIDEWALKS AND MULTI-USE PATHWAYS IN HUBBARDS AND UPPER TANTALLON

HRM is conducting community engagement sessions on the potential implementation of sidewalks or multi-use pathways around the community centres of Hubbards and Upper Tantallon. Sidewalks and multi-use pathways (MUPs) provide users with a safe place to walk, cycle, roll and access amenities in the community. They contribute to the community's growth and to its residents' wellbeing.

The purpose of these public engagement events is for staff to:

• Determine support for sidewalks or multi-use pathways around rural community centres;

• Determine community perspectives on the potential addition of an area rate tax to become eligible for sidewalks or multi-use pathways;

• Learn how communities identified in the preliminary area rate boundary for public feedback are using the community centres of Hubbards and Upper Tantallon.

Property owners, business and residents located within preliminary area rate boundaries identified for community feedback in Hubbards area and Upper Tantallon area are invited to participate in one of the following ways:

 Attend one of the in-person public engagement sessions. A full list of dates and times for these sessions can be found <u>here</u>.

- Provide feedback by filling out an online survey found on the Shape Your City <u>website</u>. The online survey for Hubbards is now open and feedback can be provided until April 15, 2024. The online survey for Upper Tantallon will open on March 1, 2024 and feedback can be provided until April 21, 2024.
- Pick up a paper copy of the survey at one of the in-person engagement sessions or contact Emma Martin, Project Manager to request a paper copy of the survey by calling 902-490-4920 or by emailing <u>martinem@halifax.ca.</u> Return the completed survey to a public library or Halifax Recreation Centre to be included in the internal mail or send by Canada Post before April 15, 2024.

Feedback received from public engagement will be included in a final report for Halifax Regional Council to decide on the implementation of sidewalks or multi-use pathways in rural communities. If supported by communities, and approved by Regional Council, planning and design phases would begin to determine a priority list.

RURAL TRANSIT SUPPORTS INCREASED BY REGIONAL COUNCIL

For nearly a decade, Halifax Regional Municipality has been supporting rural transit through the Rural Transit Funding Program. The following four service providers currently receive grants under this program: BayRides, East Hants Community Rider, MusGo Musquodoboit and MusGo Valley-Sheet Harbour.

I am so pleased to support amendments to Administrative Order 2014-012-ADM to allow for a one-time increase in the 2024/25 fiscal year in response to increases in operating costs for these rural transit service providers. Staff have also been directed to amend this Order to account for inflation by increasing funding annually based on the five year average for inflation. For more information, click <u>here</u>.

ZERO EMISSION BUS PROJECT PREVIEW

On February 16th, I joined councillors, HRM staff, contractors, and the project team at Colliers to tour the new electric buses that will be added to Halifax's Transit Fleet.

Halifax Transit is working towards transitioning to a fully zero emissions fleet and this project will result in the addition more than 200 electric buses to the Halifax Transit Fleet. We also toured the Ragged Lake Transit facility to see the expansion project underway.

The Zero Emission Bus Project Aligns with municipal, provincial, and federal climate targets and will help to achieve the goals and actions outlined in HRM's HalifACT plan.

COMMUNITY GARDEN APPLICATIONS ARE OPEN

The average distance that food travels to get to Nova Scotia is 4,000km. This makes the municipality's food system particularly vulnerable to climate change. If there is an unexpected event or emergency that causes widespread instability, we may not have the local resources to meet the needs of our residents. Community gardens are one way to support the local food system.

Many community gardens in Halifax are operated by residents on land owned by the municipal government. These are small-scale sites operated by non-profit societies for one or more of the following purposes:

- 1. Growing produce
- 2. Production of a floral or landscape display
- 3. Demonstration gardening or other related instructional programming

Community gardens can include vegetables, fruit, herbs, flowers, native and/or ornamental plants established and operated within existing municipal regulations, bylaws and assessments.

Thinking about starting a community garden?

To start a community garden, you must be a non-profit group and submit an application before the March 30 deadline.
