## EMERGENCY RECOVERY COMMUNITY MEETING

On Thursday, July 20, I will be hosting a community meeting at the St Margaret's Centre located at 12 Westwood Blvd in Upper Tantallon. The meeting will take place from 6 to 8 p.m. Representatives from HRM's Emergency Management Office, HRM's Community Safety Office, Halifax Fire, the Nova Scotia Department of Natural Resources and Renewables, and the Royal Canadian Mounted Police will be in attendance to provide information. I hope you can attend this meeting.

A Community Hub has been set up at the St Margaret's Centre at 12 Westwood Blvd. The Community Hub will be operating Monday to Friday 11 a.m. to 7 p.m. for the next several months. This Community Hub is where impacted residents can access information regarding the supports that are currently available, meet with support agency representatives, and communicate with our HRM Community Liaisons about your current needs. The goal of this Hub is to help guide residents through the first phase of fire recovery.

# COMMUNITY CONNECTOR ROADS AND EGRESS

Since being elected in 2020, I have been an advocate for community safety. In January 2021, I moved to develop a plan to both budget and build community connector roads. This report is expected to come to Council this year. I requested staff adequately budget and plan for population growth and future community development including establishing new fire and emergency services assets such as land, fire stations, access to water sources, dry hydrants, egress roads, and more.

Building back exits for 30-year-old subdivisions in District 13 is complicated. These roads and subdivisions were originally approved by the Department of Transportation. There are multiple landowners involved including various departments of the Province of Nova Scotia, Nova Scotia Power, and private landowners. The roads may be provincial or municipally owned. This complexity is causing delays to build these much-needed exits.

On June 7, 2023, I specifically requested that staff investigate developing egress for Westwood Hills subdivision in Upper Tantallon. I will continue to press the province to allow egress through crownland. The egress built in June for Haliburton and Highland Park were possible because HRM owns the land.

#### **UNITED WAY FUNDING**

The United Way Halifax is committed to being there for residents during the recovery and social network restoration process as a result of the wildfire. The Wildfire Recover Appeal will disburse funds in stages to ensure that funding matches the evolving needs of the community.

Phase One funding is supporting needs such as food and grocery store gift cards, special cleaning supplies, transportation costs and the cost of living expenses due to displacement.

#### TREES

The Municipality recommends having any mature trees on your property assessed by either a Professional Arborist or Professional Forester. While the canopy may have or may not have been impacted, if the fire damaged the roots, the tree may still be compromised and could be a current or near future risk. In terms of tree disposal, consider both risk tolerance and esthetic desire. From an ecological perspective, there is value in retaining the remaining organic material for the future productivity and health of the site.

Envirosoil Limited, 48 Quarrystone Drive, Rocky Lake Quarry, Bedford will accept ash, ash-impacted soil, ash-impacted debris, burnt trees and charred wood. Please note Halifax C&D does not accept ash, ashimpacted soil, ash-impacted debris, burnt trees and charred wood. #### WATER SAMPLING

The province of Nova Scotia recommends that well water testing occurs every six months for bacteria and every two years for chemical contaminants. #### **NO BURNING AFTER MIDNIGHT**

In the Halifax Regional Municipality, open air burning is not allowed between the hours of midnight and 2 p.m. The time of day may be further restricted by provincial or municipal bans. Check for bans every time before you burn. They are posted 2 p.m. every day at <u>novascotia.ca/</u> <u>burnsafe/</u>. #### **BBQ SAFETY**

To stay King or Queen of the grill you must include some basic "fire safety" ingredients in your barbecue recipes. • Whether fueled by charcoal or gas, barbecues are approved for outdoor use only – they emit carbon monoxide.



•Never barbecue in your garage, tent or other enclosed space.

• Read and follow all manufacturers instructions.

• Place your barbecue on a solid surface so it cannot tip over and be sure it is a safe distance from anything that can burn - we've all seen the results of a barbecue that was used too close to vinyl siding. Remember too that since barbecues do get very hot you need to keep children and pets away as well.

• Be cautious of wind strength and direction before using your barbecue and always stay with your barbecue when it's being used.

#### **BLUE GREEN ALGAE SAFETY**

Blue-green algae, or cyanobacteria, are naturally found in freshwater environments like lakes, ponds, rivers, and streams. They thrive in warm water and can be harmful to people and fatal for pets. Algae blooms can look like fine grass clippings in the water, spilled paint, pea soup or sometimes like a thick scum on the surface. Algae mats can look like clumps of vegetation, and can appear black, brown, or dark green in the water. On the shoreline they may appear brown or grey.
