NORTH WEST COMMUNITY COUNCIL

The North West Community Council met on September 25th at 7 p.m.

During the meeting a staff report was presented regarding <u>Case 23904</u>: <u>Amendments to the</u> <u>Timber Trails Mobile Home Park Development</u> <u>Agreement, 1036 Lucasville Road, Lucasville</u>

Upon review of the staff report the North West Community Council moved to give notice of motion to consider the proposed amendments to the existing development agreement to expand the area of the development agreement to include the sewage treatment facility for the park, and schedule a public hearing.

CELEBRATING MI'KMAQ HISTORY MONTH

October is Mi'kmaq History Month, a time to commemorate the rich history, proud culture and important contributions of the Mi'kmaq. In 1993, Premier John Savage and Mi'kmaw Grand Chief Ben Sylliboy declared October as the official month to recognize and celebrate Mi'kmaw culture and heritage.

Treaty Day, October 1, officially kicks-off a month of celebrations. This year's theme is *Mi'kmaw Traditional Games & Sports*. Below are some ways you can recognize Treaty Day and Mi'kmaq History Month:

RIGHT-OF-WAY CHARGE UPDATE

The Halifax Regional Municipality is advising residents that the Right-of-Way (ROW) charge has moved from the Halifax Water bill to the municipal tax bill.

The ROW charge will change from a flat \$40 annual fee that has previously appeared on residents' Halifax Water bill (as either a onetime lump sum or quarterly charge) to a new amount based on the assessed value of the property that will appear on their next municipal property tax bill in fall 2023.

The ROW charge is for the maintenance of roads, bridges, trees, lighting, signage and guard rails, as well as for the management of stormwater that comes from the public street right-of-way into Halifax Water's stormwater system. Stormwater is the water from rain, melted snow and ice that runs off from roofs, parking lots, driveways and other hard surfaces. The municipality is responsible for paying Halifax Water for the impact on their stormwater system. The municipality's ROW charge applies to all properties within the municipal stormwater service boundary. Roads within the municipal stormwater service boundary are owned by the municipality and the services are provided by both the municipality and Halifax Water. For roads outside of the service boundary, services are provided by the Province of Nova Scotia.

HAZARD RISK AND VULNERABILITY ASSESSMENT

The Halifax Regional Municipality's Emergency Management Division will be conducting Hazard, Risk and Vulnerability Assessments. These assessments are used as a tool to understand community vulnerabilities and mitigate emergency risks and hazards. This program will be divided into four phases and will establish profiles and recommendations for action for each municipal district.

If you are interested in contributing to the Hazard, Risk and Vulnerability assessment for District 14 you can do so in one of two ways. The first is to participate in the Public Engagement session being held on **Wednesday October 11th from 6 p.m. to 8 p.m.** at the Sackville Heights Community Centre. INTERSECTION SAFETY

Intersection related collisions account for the majority of fatal and injury collisions in HRM. We all have a shared responsibility in keeping our roads safe:



- Follow traffic regulations
 Be mindful of other road users
- Avoid distractions
- Exercise caution

 Remain watchful of changing road and weather conditions

Drivers

- Make sure there is enough space between your vehicle and the vehicle ahead of you.
- As you approach an intersection, look left and right to scan your surroundings.
- Come to a full stop at stop signs and red lights.
- When approaching an amber or yellow light you must stop if you can do so safely.
- If the light is green, scan left and right before proceeding through the intersection or entering the intersection to make a left or right turn.
- Do shoulder checks, mirror checks and use signals before turning. When turning right do a double shoulder check for cyclists.
- Yield to pedestrians at intersections. Crosswalks exist on all legs of an intersection, whether marked or unmarked. Turning vehicles at signalized intersections must yield to pedestrians crossing on the walk signal. If the intersection doesn't have traffic lights, drivers must yield to pedestrians waiting to cross or when they're already in a

crosswalk. Drivers must wait until pedestrians are completely across the road before proceeding.

Pedestrians

- Look both ways, try to make eye contact with motorists and walk across only when it is safe to do so.
- When available always take advantage of marked crosswalks.
- It's the law to use flashing light at crosswalks where available. Make sure to press the button where it is available.
- Consider wearing bright colours or reflective clothing when walking in the evening, at dusk or dawn and when the weather conditions make visibility poor.

Cyclists

- Use hand signals to let other road users know your intentions at intersections.
- If you decide to cross the street using pedestrian signals, get off your bicycle and walk it across the street.
- Approach intersections with caution and look for vehicles slowing down to turn right.
- Consider wearing or applying bright colours and applying additional reflective materials or to your bicycle.
- You are legally required to have a light at the front of your bike (or e-scooter) and a red reflector or red light at the back.
- o Always wear your certified helmet.

Let's all work together to make intersections safer for everyone.

COUNCIL MEETING -SEPTEMBER 12TH, 2023

During the Regional Council Meeting on September 12th, 2023, Max Chauvin, Director of Housing Homelessness, gave a presentation to Council about the latest updates to the Municipal Homelessness Strategy.

While the province is responsible to lead addressing homelessness in all of Nova Scotia's municipalities, the Halifax Regional Municipality also has an important role to play.

Council was asked to vote on six different motions created as result of the presentation. These motions will be used to help direct the CAO and staff about the priorities of Council when addressing Municipal Homelessness.

1. direct the Chief Administrative Officer (CAO) to lease private property, if possible, as locations for persons experiencing homelessness to shelter.

2. endorse an exception to the June 14, 2022, criteria prohibiting the use of active sports fields for homeless encampments for use of the Halifax Common for the purpose of sheltering.

3. direct the CAO to establish additional encampments, temporary housing, or tiny home locations on all types of municipality-owned properties. Such sites may include rights of way, parking lots, and surplus lands.

4. direct the CAO to write to the province requesting their immediate plans to create deeply affordable housing options in HRM, including the leasing of private property for persons experiencing homelessness and October 2023 request the province provide on-site wraparound services for homeless encampments that have over ten people.

5. direct the CAO to explore the options of the non-park property types outlined in the staff report dated September 4, 2023, as well as campgrounds, and outdoor facilities, as locations for unhoused persons who are sheltering in a vehicle.

6. direct the CAO provide a staff report to explore the feasibility of purchasing and installing pre-fabricated structures, similar to the Sprung structures in Toronto, to provide rapid response emergency housing in HRM including funding opportunities for installation and operation, that include other orders of government and the private sector.

Housing insecurity and homelessness continues to be an issue in our region, and we are committed to applying resources to support efforts aimed at helping to address homelessness.
