FUTURE INFO & INPUT ON DITCH TAX

As part of its ongoing commitment to engage the local community and provide information to residents and property owners, Halifax Water (HW) is continuing its Public Information Sessions for the pending stormwater service expansion into East Preston, Lake Echo, Mineville and the western area of Lawrencetown. The change in responsibility for stormwater service is the result of a recently approved transfer of local road infrastructure from the Province of Nova Scotia to HRM. With this transfer, subject to approval from the Nova Scotia Utility and Review Board (NSUARB), HW will take responsibility for managing stormwater infrastructure effective June 2022. The HW initial Information Sessions began in late November 2021 and there will be more in mid-to-late January 2022. Actual dates and venues will be advertised and posted onto the local Facebook Pages. During these Information Sessions, there will be story boards and maps along with representatives from Halifax Water to answer your questions. There are no formal presentations so attendees are welcome to drop-in at any point. Proof of Vaccination is required to gain admittance. If public health measures or related concerns for public safety such as stormy weather conditions require HW to cancel or postpone these public information sessions, HW will e-mail updates to property owners who have signed up for updates at www.halifaxwater.ca/ stormwater-expansion. It should be noted that those affected by these changes can express their opinions with Letters of Comments to the NSUARB by Wednesday, February 2nd . MOOSELAND POSTAL CODE CHANGE

Please be advised that Canada Post will be proceeding with its civic mailing address adjustments that affects the Mooseland and Tangier area. The 45 Points of Calls (POCs) that are currently using the "Mooseland" community name will be told to change their postal code from BoJ 2Jo to BoJ 3Ho. Furthermore, the 426 POCs in the Tangier area will be formally advised via a Canada Post customer letter in mid-January to discontinue the use of any non-civic formatted addressing such as Site # - Box # or RR# General Delivery.

MUSQ. HBR. DEVELOPMENT PLAN

On Nov. 23/21 HRM Regional Council voted to proceed with aspects of the Musquodoboit Harbour Community Development Plan (MHCDP). The process is to consider amendments to the Eastern Shore West Municipal Planning Strategy and Land Use By-laws to ensure development provisions for commercial, industrial, institutional, open space and recreational uses are compatible with the village core and support carrying out the vision of the MHCDP. It recommends that \$100,000 be set aside in the upcoming 2022/23 operating budget to study servicing options for a Wastewater Management District in Musquodoboit Harbour and to explore funding options from other levels of government for the detailed design and capital cost of sidewalk infrastructure. 2021 CITIZENS SURVEY RESULTS

Back in September, various HRM residents received an invitation to participate in the 2021 Resident Survey either online, by mail, or by telephone. Invitations were sent to 20,000 randomly selected households across the municipality, with each district receiving a portion of invitations reflective of its proportion of the total population of the Region. The survey asked a broad range of questions about municipal services, resident preferences and priorities, and satisfaction with services and service experience. The results will be used to guide the Municipality with its immediate and long-term business and budget planning.
