OPEN-AIR BURNING SEASON AGAIN

As of October 16th (weather permitting) and as long as the NS Forest Weather Index (FWI) is at a low to moderate reading, the Open-Air Burning Season outside the HRM Urban No-Burn Zone will be allowed. HRM is in the process of amending its own Open Air Burning By-law and Administrative Order in order to align with the new Provincial regulations. FINAL TAX BILL DUE - OCT. 31st

HRM sends out its property tax bills in two phases and invoices all property owners twice each year. The Final Tax Bill was mailed out in September with a final due date of Friday, October 31st. The tax calculation is based on the taxable assessed value of the property multiplied by the applicable tax rate. The taxable assessed value is determined by the Property Valuation Services Corporation – www.PVSC.ca . The tax rate is the sum of two levies - a general rate (Urban, Suburban or Rural) and any local area tax rates within a district. NCC EASTERN SHORE ACQUISITION

The Nature Conservancy of Canada (NCC) in Nova Scotia has acquired two sensitive ecological areas along the Eastern Shore. A 465 acre (188 hectares) site at Fishing Lake in the Ship Harbour / Long Lake area, just east of Lower Meaghers Grant. And Young's Island which is an

84 acre (34 hectares) property in Musquodoboit Harbour, just north of Martinique Beach. For more information visit: www.natureconservancy. ca/en/where-we-work/nova-scotia/. There will be some public consultations by the Department of Natural Rescources in Spring 2015 to discuss maintaining off road access for ATVs and snow-mobiles through the Lays Lake Road corridor for traditional recreational use.

PORTERS LAKE ACTIVE TRANSPORTATION GREENWAY AID

The NS Government is providing \$100,000 towards the implementation of the Porters Lake AT Greenway plan that will connect residents with the Metro-X Transit Terminal, Porters Lake Elementary School and the Lake and Shore Community Recreation Centre. About a kilometer (900m) of the trail system will be paved. The project will also cross over the Hwy #107 Exit 20 overpass interchange and connect to the Blueberry Run Trail in West Chezzetcook. Total project cost is estimated to be \$340,000.

COMMUNITY HEALTH BOARD FUND

The Southeastern Community Health Board that serves the western portion of District 2 area has funding available for local groups and organizations working to improve the health and well-being of its citizens. They serve the communities Cole Harbour, Westphal, Lake Loon, Cherry Brook, East Preston, North Preston, Lawrencetown, and Mineville. Application deadline for proposals is Monday, November 3rd.
