## SENIOR SNOW REMOVAL PROGRAM

There's no denying it – winter is on its way. There is a snow removal program available for seniors (ages 65 and older) and persons with disabilities to help ensure safe access to your home.



### The Senior Snow

Removal program is a YMCA program provided in partnership with Halifax Regional Municipality, and oversees the clearing of front and back steps, walkways, ramps, and access to fuel tanks. Please note that the program does not include driveway clearing. Those 65+ or persons with disabilities must also meet the following eligibility criteria:

 $\checkmark$  The participant must reside in a single dwelling home which is owned or rented;

✓ The participant, also including all individuals who live on the premises aged eighteen or older, must not exceed a total gross household income of \$32,000, and;

 $\checkmark$  The participant may not be a landlord.

The Senior Snow Removal program operates on a first-come, first-serve basis. When maximum capacity is reached, the program will come to a close and individuals will be placed on a waitlist. ## **Ross Road Realignment Update**

As many of you are aware, there has been a push to realign Ross Road with the intersection at Lake Major Road. This would greatly increase the safety of this intersection by aligning it with a lighted intersection. Staff have advised that the project continues to move through the planning stages with the corridor geometry and survey work completed. Land requirements are being advanced along with detailed engineering design and preparation of tender documents for the project to advance to construction in 2026/27. However, this is contingent on the Council deliberations of the capital budget, set to take place on Tuesday December 12<sup>th</sup>. An update will be included in our January Enewsletter.


## Provincial Affordable Housing Announcement on Sherwood Street

# NATIONAL DAY OF REMEMBRANCE AND ACTION ON VIOLENCE AGAINST WOMEN

The <u>National Day of Remembrance and Action</u> on <u>Violence Against Women</u> is recognized annually on December 6. This day was chosen in memory of the fourteen women who tragically lost their lives in the École Polytechnique massacre on December 6, 1989. This act of violent misogyny led the federal government to formally recognize this day, with a goal to increase awareness around violence against women.

On December 6, honour the 14 women who lost their lives at Polytechnique Montréal by observing a moment of silence at 11 a.m. and wearing a white ribbon if possible.

It is important to remember that violence can affect women from all backgrounds regardless of age, race, sexual orientation, immigration status, ethnicity, education or income.

During the COVID-19 pandemic, police services, shelter and community-based organizations reported an increase in violent acts towards women, girls and gender-diverse people. Communities across Canada and the world began to see a <u>shadow pandemic</u> of increased violence against women. Due to calls for social justice regarding violence against women of colour, and the National Inquiry into Missing and Murdered Indigenous Women and Girls, there has been an amplified awareness around gender-based violence in recent years.

## How can you help?

Preventing and ending gender-based violence is everyone's responsibility. You can be part of the solution when you:

- Listen to and support survivors of gender-based violence. For example, you can learn about the experiences of Black and Indigenous survivors within our region with Avalon Sexual Assault Centre's recorded <u>learning event from</u> <u>2022.</u>
- Speak up when you see harmful behaviour and maintain confidentiality if someone in the workplace has experienced gender-based violence.

If you or a loved one is experiencing violence, speak with someone you trust about getting support.

- Call 911 if you or someone you know is in danger.
- To connect with community services including legal aid, counselling, family resource centres, housing, and accessibility support within the municipality, call 211 or <u>search online for community resources</u>.

# IMPROVEMENTS, AMENDMENTS AND ADVANCEMENTS TO AFFORDABLE HOUSING IN THE MUNICIPALITY

On November 14<sup>th</sup>, Regional Council passed a series of motions to amend, improve, and

advance affordable housing in the municipality. A full



overview of the motions and background information can be found in the <u>staff report</u>.

At the November 14<sup>th</sup> Regional Council Meeting, the motion was advanced that the Administrative Order Number 2020-007-ADM Respecting Incentive or Bonus Zoning Public Benefits and Administrative Order Number 2020-008-ADM Respecting Grants for Affordable Housing both be amended, so that money collected through the Interim Density Bonus Program can be used to fund eligible public benefits, including affordable housing, in the Suburban Area (outside the Regional Centre). This will ensure that the Halifax Regional Municipality can fund affordable housing projects throughout the entire municipality to ultimately support more residents in need.

Staff also recommend expanding eligible partnerships between private businesses and Non-Profit Organizations (NPOs), by allowing eligible NPOs to lease privately owned property or housing and maintain their eligibility for Affordable Housing Grants Program funding. Additionally, on November 14<sup>th</sup>, in light of <u>Bill</u> <u>329</u> and the Interim Density Bonus Program, staff also recommend that, for the 2023/2024 Grant year, \$200,000 be allocated from the Housing Accelerator Fund to support suburban and rural affordable housing projects.

Finally, at the meeting, the motion was advanced for a review of the Affordable Housing Grant Program to be undertaken before the 2024/25 grant year to ensure the ongoing effectiveness of this program. For more information, read the full <u>staff report.</u>

# INTERNATIONAL HUMAN RIGHTS DAY



Human Rights Day is observed every year on December 10 to commemorate the day in 1948 the United Nations General Assembly adopted the <u>Universal Declaration of Human</u>

<u>Rights</u> (UDHR). This year commemorates the 75<sup>th</sup> Anniversary of the Universal Declaration of Human Rights, which coincides with the 30th anniversary of the Office of the High Commissioner for Human Rights.

The UDHR is a milestone document, which consists of a preamble and <u>30 articles</u> that sets out a broad range of fundamental human rights and freedoms to which all of us, everywhere around the world, are entitled. It guarantees our rights regardless of race, color, religion, sex, language, political or other opinion, national or social origin, property, birth or other status. Available in more than <u>500 languages</u>, it is the most translated document in the world.

In its preamble, the UDHR also highlights the "recognition of the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice and peace in the world."

## PERFORMING & VISUAL ARTS VENUES STUDY

The Halifax Regional Municipality is seeking public input on the Performing & Visual Arts Venues Study.



Happy Cities, on behalf of the municipality, are conducting a study of performing and visual arts venues across the region. The study will help improve the municipality's understanding of professional art venue operations, identify challenges facing existing art venues, identify the needs of the local arts and culture community and inform the municipality's longterm approach to supporting, renewing and investing in professional arts venues.

As part of the Performing & Visual Arts Venues Study's engagement program, Happy Cities is seeking feedback from users of performing and arts venues on their experience with these facilities. Happy Cities is also releasing a second survey to collect input from Indigenous artists and peoples.

There are two surveys available: a <u>Public</u> <u>Survey</u> and an <u>Indigenous Residents Survey</u>. The surveys will remain open until **Friday**, **December 15**.

The Performing & Visual Arts Venues Study is expected to be completed by June 2024, and may lead to the creation of a Professional Arts Venues Plan.





## **SNOW SEASON IS HERE**

With each weather event, snow clearing crews are responsible for approximately 3,844 lane kilometres of streets and about 1,000 kilometres of sidewalks! We can't control Mother Nature or what this winter has in store, but if we work together, we can all be better prepared for whatever the season may bring.

### SERVICE STANDARDS:

HRM has service standards for streets, sidewalks, and bus stops and the timing varies depending on the priority level. We prioritize commonly used streets, bus routes and roads that provide access to hospitals and schools. When the snow stops, operators work as quickly and safely as possible to have all the roads cleared within 24 hours and major roads and bus routes within 12 hours.

Before contacting 311 about snow clearing, please ensure the service timelines for your area have expired. You can find detailed information about snow clearing service timelines on the interactive map or in the "when should clearing be complete?" section on the <u>website</u>.

If your street or sidewalk has not been cleared by the indicated time in each chart, please email <u>ContactUs@311.halifax.ca</u> or call 311 so crews can be dispatched to address the issue. If an emergency vehicle needs to access a street, staff dispatch a plow immediately to that street.

Residents should note that in snowfalls greater than 30 centimeters or in blizzard conditions, more time may be needed to complete clearing. The same exception may apply when there are rapidly changing weather conditions. Crews will continue working until all streets and sidewalks are clear and safe. Of course, some roads are taken care of by the province, depending on where you live. Provincial road information can be found <u>here</u>.

## WINTER PARKING:

The municipal overnight winter parking ban is in effect annually from December 15 to March 31. The ban is enforced from 1 a.m. to 6 a.m. during declared weather events and snow removal operations only. Sign up for <u>hfxALERT</u> notifications to receive important updates from the municipality, including Winter Parking Ban notifications.
