#### LITTER CLEAN UP RESOURCES



Residents and groups looking to clean up litter in their communities can access programs supported by HRM Solid Waste Resources.

Between the months of April to November, residents of HRM can register with the Great Nova Scotia Pick Me Up (GNSPMU) by visiting their website. GNSPMU is coordinated by Divert Nova Scotia and is supported in part by HRM. Upon registration, residents can pick up their free litter cleanup kit, which consists of litter bags and nitrile gloves, at their local Halifax Public Library or at one of the three Customer Service Centres located throughout HRM.

In addition to providing litter kits, HRM also provides three different disposal options for residents participating in the GNSPMU program. These disposal options include:

- Placing the materials curbside to be collected on your next garbage collection day if it does not exceed curbside bag limits.
- 2. Taking the materials directly to the Otter Lake landfill for disposal. HRM will waive tipping fees for any groups or residents who are registered with the GNSPMU.

3. Residents can also get the materials picked by HRM road operations. Residents who choose this disposal option must contact 311 two weeks prior to their litter clean up date to help ensure that the materials are collected.

# MUNICIPALITY IMPLEMENTS SPRING WEIGHT RESTRICTIONS

To minimize potential damage to municipal roads, HRM has introduced its annual spring weight restrictions on March 5<sup>th</sup>.

These restrictions are for heavy vehicles travelling on municipally maintained roads. Residents can view which roads are exempt from spring weight restrictions on a <u>map</u>, or by reviewing the attached list. Regular weight tolerances apply on exempt roads.

The weight restrictions are expected to remain in place into the spring, at which time the municipality will advise when the restrictions are lifted.

The municipality's spring weight restrictions are consistent with those of the Nova Scotia Department of Public Works. More details of vehicle restrictions can be found online.

# 2023-24 TO 2025-26 HALIFAX PUBLIC SAFETY STRATEGY APPROVED

An updated Halifax Public Safety Strategy has been approved for 2023-24 to 2025-26.

The Halifax Public Safety Strategy is a strategic framework for guiding all municipal decision-making, regarding public safety. The four strategic priorities of this framework include:

- 1. Building Resident Resilience;
- 2. Ensuring Safe Spaces;
- 3. Strengthening Communities; and,
- 4. Preventing and Reducing Crime.

The Halifax Public Safety Strategy adheres to the municipality's mandate to sustain safe and viable communities and is built on an understanding that partnerships with the province and other stakeholders are vital to moving this work forward in a meaningful and sustained way.

Throughout the development of the updated Halifax Public Safety Strategy, consultations occurred both internally with business units and Regional Council, and externally with community stakeholders and service providers.

Additional external engagement with service providers, community organizations, and communities will continue as the actions within the strategy are advanced, including the establishment of a community voice and advisory structure.

### **CHANGES TO PARKING PERMITS**

As of Saturday, April 1, changes to annual parking permit fees, visitor parking permits, commuter permits, carshare parking and the ability to purchase second permits will be in effect.

- Annual parking permit fees will increase from \$40/year to \$75/year.
- Residents can purchase a second annual parking permit for \$175/year.
- Annual visitor parking permits will shift to pay-per-use:

One day: \$15Two days: \$25Seven days: \$35

- Carshare vehicles will be able to park at any on-street paid parking location.
- Commuter permits will see price increases or price decreases, depending on the zone. Student commuter permits will change from a flat rate of \$35/month to \$10/month discount off the regular zone price.
- All permits will shift to a digital format, removing the need for replacement fees.

These changes, supported by amendments to <a href="By-law P-1200">By-law P-1200</a> and approved by Regional Council, will streamline purchases, increase flexibility and create efficiencies in a new digital format. These changes are also based on resident feedback and will better align with residents' needs and better reflect the cost of administering these programs.

All current parking permits will remain valid until they expire.

#### **HEMDCC NOW STREAMED ONLINE**

As part of continued efforts to support open and accessible meetings, webcasts will now be available from the Harbour East – Marine Drive Community Council Chamber (60 Alderney Drive, Dartmouth), thanks to some recent technical upgrades. This means that all Harbour East Marine Drive Community Council (HEMDCC) meetings that take place at that location will be streamed online for residents to watch. This follows a soft launch webcast pilot that occurred at the HEMDCC meeting on January 12<sup>th</sup>. This pilot was a success and the video from this meeting can be found here.

# DISTRICT 4 RCMP ROAD SAFETY STATS: FEBRUARY 2023

Calls for service were down just over 14% in February from last year.

RCMP responded to 520 calls for service including issuing tickets for 25 summary offences, 4 aggressive driving, 2 cellphone use, 4 invalid inspection sticker, 4 speeding offences and 11 other motor vehicle act violations like lack of registration and insurance.

There was 1 impaired driving charge and 3 suspensions in February and RCMP completed 86 traffic stops. They also responded to 28 motor vehicle accidents, versus 16 in February 2022. For more information on our RCMP's work in the community, see their website.
