COMMUNITY CORNER

Update on 78 Sherwood Drive:

In order to qualify for the Housing Accelerator Fund (HAF), HRM are updating some of our planning regulations and are reviewing specific development proposals including 78 Sherwood. The proposal for this location includes three 3-storey multi-unit buildings and 8 townhouse units. Staff have concluded public engagement and a report will come to Regional Council this Spring with recommendations.





New Development Application for 1226 Cole Harbour Road and 77 Bissett Road:

There has been a Development Application for a longterm care facility and four apartment buildings for this location.

There will be a Public Information Meeting at Cole Harbour Place for interested residents on Monday, March 18 from 7 to 9 p.m. HRM planning staff will be in attendance to answer questions. Caldwell Road – Phase 2:

There has been a delay in the construction of the second phase of the Caldwell Road recapitalization project. HRM is waiting on Nova Scotia Power for the relocation of the power poles. There have been some unforeseen challenges and the new date for Caldwell Road phase 2 completion has been pushed out to 2025.

Planning Application 2023-001187-Montague Road, Lake Loon:

Fathom Studio on behalf of the property owner is applying to amend an existing development agreement to allow for shared housing with special care use directed at retirement living on Montague Road, Lake Loon.

2024/25 BUDGET

Regional Council has approved the 2024/25 Capital Budget and the 2024/25 Multi-Year Capital Plan, which are the basis for staff's planning and resource preparations required to implement capital projects within the current year and next three years. The 2024/25 Operating Budget is still under review with business unit presentations.

A full review of the 2024/25 Municipal Budget and 2024/25 Capital Budget will occur on Tuesday, April 23.

Some key projects in the capital plan include the Beechville Lakeside Timberlea Recreation Centre Recapitalization, Halifax Regional Fire & Emergency (HRFE) Headquarters and Station 1, Active Transportation, Sidewalk Recapitalization, HRFE Fleet Replacement, Burnside & City of Lakes Industrial Park and Electric Bus Procurement and municipal building retrofits as part of HalifACT.

HOUSING ACCELERATOR FUND ANNOUNCEMENT

As part of the Housing Accelerator Fund, the municipality is collaborating with partners and other levels of government in a national effort to support housing. The municipality is proposing updates to planning policies to enable more density and flexible housing types in residential areas.

VOLUNTARY VULERNABLE PERSONS REGISTRY

The Voluntary Vulnerable Persons Registry (VVPR) is a voluntary, self-referral list for residents of the Halifax Regional Municipality who may require support during emergency situations. It is a list only for residents without 24-hour support who experience severe difficulty with any of the following:

- Mobility
- Vision impairment
- Hearing impairment
- Developmental disabilities
- Cognitive impairment
- Mental health conditions
- Any resident who requires electricity for lifesustaining equipment such as oxygen, dialysis, etc.

The VVPR is not for all residents. For example, those receiving 24-hour support or homecare aide may not be eligible. For more eligibility requirements, and if you doubt whether the VVPR is right for you, view more information online at <u>halifax.ca/vvpr</u> or by calling 311.

SIGN UP FOR HFXALERT

HfxALERT is a mass notification system that HRM utilizes to provide timely alerts with important urgent and non-urgent information. It will strictly issue municipal notifications. These alerts may be urgent, such as evacuations, or non-urgent, such as overnight winter parking bans. The notifications will be sent via email, automated phone call and/or text message.

Residents need to sign up to receive these alerts: Notifications will be sent by Halifax Regional Police, the Halifax Regional Fire & Emergency's Emergency Management Division and HRM Corporate Communications.
