NO OPEN FIRES!



The <u>Province of Nova Scotia has announced</u> <u>burn, travel, fireworks and activities</u>
<u>restrictions</u>. The restrictions are in place until
June 25th or until conditions allow them to be
lifted. There is a provincewide ban on open
fires because of dry conditions. The ban applies
to fires in provincial parks, private
campgrounds, backyard campfires, brush
burning and fireworks. Follow <u>#novascotia</u> or
check the provincial <u>BURN map</u> for updates.

As crews battle multiple fires, there is a **zerotolerance policy** in effect for the duration of



the outdoor burning ban. Fines will be issued against those who are burning outdoors, which includes a penalty ranging from \$250 and \$10,000. Any person responsible for fire spread can also be required to pay all expenses related to controlling or extinguishing the fire, and all related fire damages.

Illegal outdoor burning puts lives, properties, and the environment at risk. It also ties up critical fire department resources.

All residents and businesses who have been required to evacuate must register with 311 via the <u>online form</u> (or by calling 1.800.835.6428), as staff will follow-up when more information becomes available.

Comfort centres are temporary accommodations where food and water are provided, as well as a place to charge devices and receive up-to-date information, when residents are impacted by prolonged power outages, extreme temperatures or other significant events.

The evacuation centre is open 24/7 and will remain open for the foreseeable future until it is no longer needed.

An evacuation centre is a type of emergency facility which is opened when residents have to be evacuated from their homes due to a specific emergency event and where evacuees are received, needs are identified, and food, water and overnight accommodations are provided.

STORMWATER RIGHT-OF-WAY CHARGE

Why do I get billed for the Right-of-Way

In a 2013 rate hearing decision, the Nova Scotia Utility and Review Board (NSUARB) directed that the portion of stormwater costs related to the street right-of-way should be billed to the Halifax Regional Municipality. Until 2016, this amount was billed on Halifax Water bills. The charge briefly appeared on municipal property tax bills in 2016/17. Since 2017, Halifax Water has collected the Right-of-Way charge on behalf of the municipality and that is why it appeared on the Halifax Water bills.

As directed by Regional Council on January 10th, 2023, the required amount – currently \$5.3 million per year – will now be collected through the municipal property tax billing process as an area rate. This charge will appear on the property tax bill as "Right-of-Way" charge.

The municipality's Right-of-Way charge applies to all properties within the municipal stormwater service boundary; roads within the municipal stormwater service boundary are owned by the municipality and the services are provided by both the municipality and Halifax Water. For roads outside of the service

boundary, the services are provided by the Province of Nova Scotia.

How is the Right-of-Way charge calculated?

When the municipality collected the Right-of-Way charge in 2016/17, the charge was a flat fee on the property tax bill and created challenges for certain types of properties, such as condos, leased land communities, and water lots. Beginning in 2023/24, the Right-of-Way charge will be an area rate and property owners will pay a rate multiplied by the assessed value of their property, similar to other charges on the property tax bill.

Property owners with an assessed value of up to \$475,000 will see a lower charge than what they were paying to Halifax Water, while property owners with an assessed value of over \$475,000 will see an increase. This will be a new charge for approximately 26,000 property owners who were not previously billed this charge because they were not billed the Halifax Water stormwater charge for their private property. With the new stormwater service boundary, these properties will now receive only the municipal Right-of-Way charge (the charge for public property).

When will I see this charge on my property tax bill and removed from my Halifax Water bill?

This change became effective April 1st, 2023, and the charge will first appear on the municipality's October 2023 final property tax bill as a separate line item. Halifax Water

customers with a billing period that begins before April 1st, 2023, will see a partial Right-of-Way charge on their bill. In these cases, the Right-of-Way charge will continue to be collected by Halifax Water for billing periods up to, and including, March 31st, 2023. As a result, customers will receive a prorated amount of the municipal Right-of-Way charge on the bills they receive after March 31st, 2023.

MOTORCYCLE SAFETY



Spring signals the start of motorcycling season in Nova Scotia. Motorcycle safety is a shared responsibility. Watch

out for each other.

2022 saw an increase in serious motorcycle collisions in HRM. Be the change in 2023. Drive

safely. Operating your motorcycle safely can help protect you and other road users. Some tips to keep in mind are:

- Take an approved motorcycle training.
- Always drive defensively.
- Travel at a safe speed.
- Only ride when sober, focused and wellrested.
- Check your blind spot before changing lanes
- Focus on where you need to go rather than looking at what you want to avoid (the motorcycle may go where you look).
- Ride within your experience and skill level.
- Go with an experienced rider the first time you explore a new area.


All motorists can help reduce motorcycle collisions. Those who share the road with motorcycles should: keep their eyes on the road; check their blind spots and mirrors before changing lanes; give motorcycles space just like any other vehicle.

TRAFFIC CALMING MAP



WEST END MALL ANNEX DEVELOPMENT



The proposed redevelopment of the Halifax Shopping Centre Annex, which is the shopping mall property bounded by the CN Rail cut, Mumford Road and Leppert Street is coming. Given the size of the site, and the number of buildings that could be built, redevelopment is expected to take many years. There are 10 property owners within the West End Mall Growth Node.

This process was initiated by Cushman Wakefield, who own most of the growth node. The applicant's preliminary plan is to remove some of the existing buildings in phases,

creating space for new streets and buildings. The applicant is proposing high density, highrise housing on much of the site, with a mix of commercial and residential land uses. The main aspects of the proposal include:

- Removing some mall buildings;
- Creating new public streets and new development blocks;
- A new municipal transit (bus) terminal, presently proposed by the applicant to be underground;
- 15 residential towers, up to 90 metres in height, on mid-rise podiums;
- A mix of residential and commercial uses;
- About 5,560 new residential units.

WATCH FOR TICKS!


According to the <u>provincial website</u>, there are several kinds of ticks in Nova Scotia, but only the blacklegged tick, sometimes known as deer tick, carries the bacteria that causes Lyme disease.

Tick-borne illnesses are preventable by taking some simple precautions to reduce your risk:

- Wear long pants and long sleeves in areas likely to have ticks
- Wear light coloured clothing it's easier to see ticks
- Wear enclosed shoes and tuck your pants into your socks
- Walk on well-travelled paths, avoiding long grass and vegetation
- Apply insect repellents containing DEET or Icaridin to exposed skin and clothes.
 Follow directions on the package carefully.



Remove a tick safely

- Carefully grasp the tick with tweezers the pointier, the better - as close to the skin as possible
- Gently and slowly pull the tick straight out of the skin. Do not jerk, twist or squeeze it
- Once the tick is removed, clean the area of the bite with soap and water or alcohol hand sanitizer.
- Make a note of the date and where on the body the bite occurred. This will be important if you, or a loved one, begin to feel unwell.

Once removed, flush the tick down toilet, drown in rubbing alcohol or freeze in a plastic sealed bag prior to putting in the garbage. Avoid crushing ticks with exposed fingers.

CN RAIL BRIDGE – JUBILEE ROAD



A full closure of the CN bridge is necessary to complete rehabilitation, repairs, and safety improvements to the aging infrastructure. The bridge cannot be open to traffic as the geometry of the structure does not lend itself to maintaining any traffic access while extensive work is being completed.

I have shared your concerns regarding traffic congestion and speed on residential streets in this area to our Traffic Authority, Right of Way staff, Halifax Regional Police and Gregory Conrad, Senior Construction Inspector. They are monitoring the situation and will take appropriate measures to ensure the safety of all during this CN Rail rehabilitation project.

Vendors are responsible for staying informed of current or upcoming procurement opportunities.

FEDERAL FOOD INFRASTRUCTURE FUND





The Local Food Infrastructure Fund (LFIF) facilitates the acquisition of equipment by non-profit organizations for the purposes of harvesting, storing, preparing, packaging and/or delivering food within their respective communities. This initiative is designed to strengthen food security in communities by

providing grants that cover 100% of project costs, ranging from \$15,000 to \$120,000.

Since August 2019, the LFIF has supported 900 growth-generating food security projects across Canada, such as: community gardens and kitchens; refrigerated trucks and storage units for donated food; greenhouses in remote and Northern communities; and more.

Eligible organizations must be community-led and dedicated to improving access to safe and healthy food so Canadians most at risk can improve their food security, including:

- Non-profit organizations;
- Municipal and regional governments;
- Indigenous organizations (First Nations, Métis, Inuit).

WATER QUALITY MONITORING



Get involved in monitoring the quality of our local lakes! The municipality's LakeWatchers program launched last year and is a great

way to help keep our lakes safe and clean.

The program will involve community teams to:

- Conduct environmental monitoring in 76 lakes across the municipality.
- Collect data, such as pH levels, to inform future actions to maintain/improve a lake's health.

 Share data with residents through future staff reports to Regional Council and through the municipality's <u>Open</u> <u>Data Portal</u>.

Data collection will take place twice yearly through internal sampling (staff or contractors) and/or trained community teams, called LakeWatchers. The municipality will leverage existing water quality community groups and welcomes new volunteers to collect data in support of this program.

Interested in getting involved? Learn more here. *Note that the LakeWatchers Program is separate from regular water quality testing for safe recreational use. This program runs every summer from July 1st to August 31st.

Land Acknowledgement

The Halifax Regional Municipality is located in Mi'kma'ki, the ancestral and traditional lands of the Mi'kmaq people. The municipality acknowledges the Peace and Friendship Treaties signed in this Territory and recognizes that we are all Treaty People.

Halifax is committed to strengthening its relationship with Indigenous communities and honouring the significant contributions of Indigenous peoples. Another way the municipality has demonstrated this is by formalizing the official Land Acknowledgement:

"The Halifax Regional Municipality is located in Mi'kma'ki, the ancestral and traditional lands of the Mi'kmaq people. The municipality acknowledges the Peace and Friendship Treaties signed in this Territory and recognizes that we are all Treaty People."

Historically, a Land Acknowledgment is a traditional practice shared amongst Indigenous groups to recognize the Indigenous land and territory they are visiting. Making a respectful Land Acknowledgement now, remains a way to express gratitude and respect to Indigenous peoples for being stewards of the land we live and work on. It is an important step in reconciliation.

In Nova Scotia, we are all Treaty People; with that comes roles and responsibilities.
