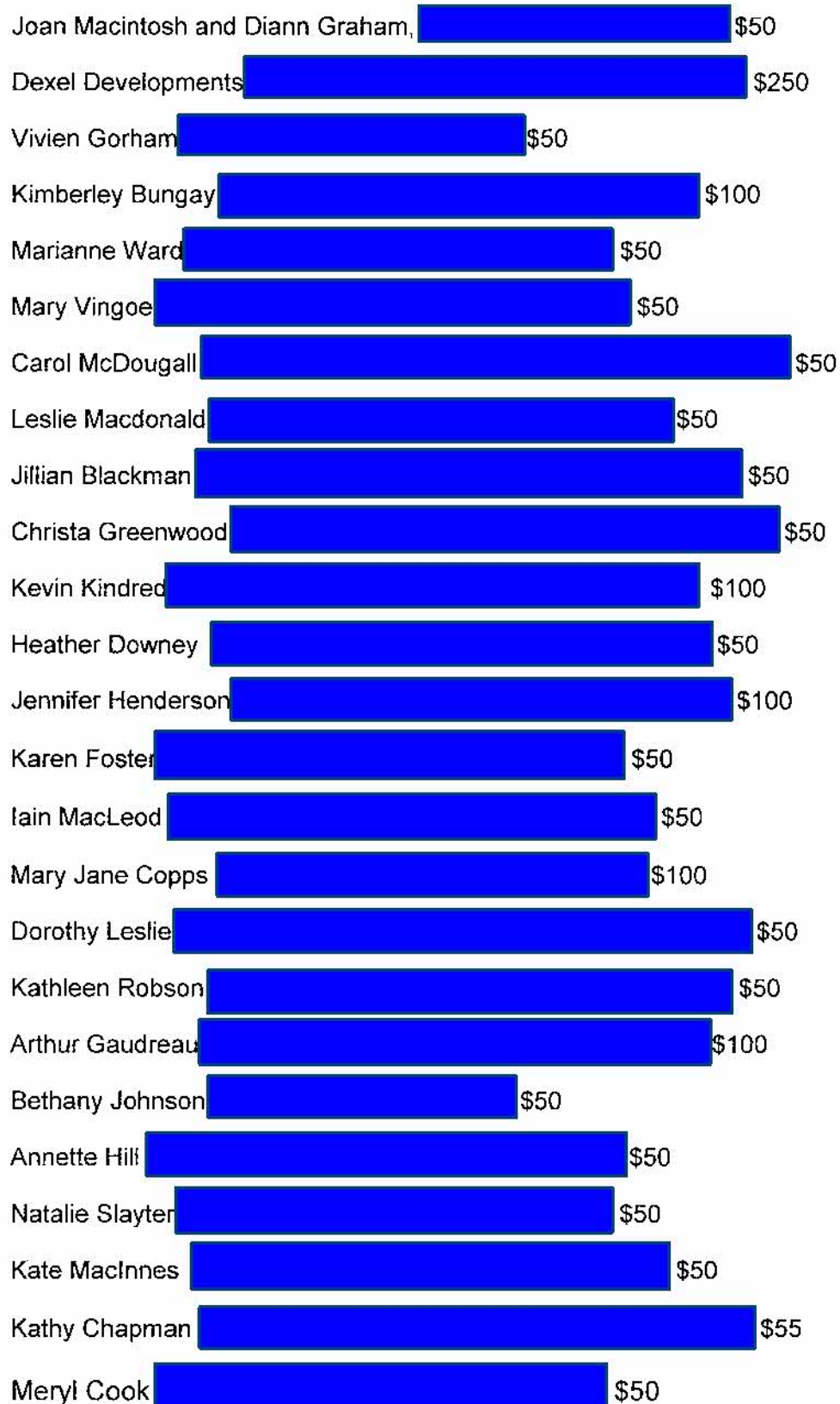
Donations to the Campaign to Elect Kate Watson (Over \$49) – 2016
