Lisa Bugden, General Manager of Neptune Theatre and Jeremy Webb, Artistic Director of Neptune Theatre provided the Standing Committee with a presentation on the Theatre's evolving business model and response to the public health pandemic. Highlights of the presentation included:

**12.1.1 Police Information Technology Audit Report –** *Evangeline Colman-Saad, Auditor General of Halifax Regional Municipality* 

The following was before the Standing Committee:

- A staff information report dated February 4, 2021
- A presentation titled Halifax Regional Police Information Technology Audit Public AFSC Presentation Dated February 11, 2021

Evangeline Colman-Saad, Auditor General of Halifax Regional Municipality, presented on the results of the Halifax Regional Police Information Technology Audit. Highlights of the presentation included:

- The scope of the audit risk management, oversight, security of information and assets, physical access, and progress on policy recommendations
- An overview of a report that was written in 2016/2017 and presented to the Board of Police Commissioners in 2019
  - Of the 67 recommendations put forward in the 2016/2017 report, the Board of Police Commissioners was told in 2019 that 13 of 67 recommendations were complete. The Auditor General's Office found that five of 67 were complete.
- 12 recommendations from the Auditor General's Office, with recommendations accepted by management of the Halifax Regional Police and a follow-up in 18 months to monitor progress

Evangeline Colman-Saad, and Ashley Maxwell, Lead Auditor, answered questions from Councillors regarding timelines, best practices and clarified recommendations made within the report.
