**12.1 AUDITOR GENERAL**

**12.1.1 Annual Audit Priorities Report**

The following was before the Standing Committee:

Evangeline Colman-Sadd, Auditor General, presented on the 2020-21 Annual Report and 2021-22 Audit Priorities. Topics included:

- Reports Released and Reports in Progress
- Strategic Goals from 2019-2021 and planning for 2021-22 and beyond
- Performance Measures
- Audit Priorities for the year ahead
- Details of a funding request to expand in-house processes for IT audits

Evangeline Colman-Sadd responded to questions and provided clarification to members of the Committee regarding property tax management, the scope of audits that have already taken place, and

outlined the process for monitoring the progress a Business Unit has made when implementing recommendations from a previous audit.

Responding to questions regarding training provided by the Canadian Audit and Accountability Foundation for Regional Council in 2019, Colman-Sadd provided details on the scope of the training and noted that the Office of the Auditor General would work with the Council Support Office to provide this training to members Regional Council in the future.

Responding to a question from the Committee regarding public input on audits, Evangeline Colman-Sadd highlighted a fraud and waste reporting form on the website for the Office of the Auditor General. Further, they noted that the Auditor General's Office will use social media to share with the public when audits will take place and encourage the public to provide information in the year ahead.

Elizabeth Taylor, Manager of Culture and Events, responded to questions from members of the Committee regarding the Nova Scotia Motor Vehicle Act and noted that cities like Ottawa and Toronto have flexibility in their open street events due to amendments made to the Ontario Motor Vehicle Act.

Andrew Cox, Senior Civic Events Coordinator, responded to questions from members of the Committee regarding the use of off-duty Royal Canadian Mounted Police and Halifax Regional Police officers at open street events.

Councillor Cleary clarified that they would like the Committee to defeat this motion in order for Alternative Recommendation 1 to be put forward as outlined in the staff report.
