14.1 CHIEF ADMINISTRATIVE OFFICER

14.1.1 Pride Rainbow Art Crosswalks

The following was before Council:

A staff recommendation report dated August 1, 2017

MOVED by Councillor Karsten, seconded by Councillor Mason

THAT Halifax Regional Council:

- 1. Direct staff to continue to include funding for the Pride Crosswalk Program as part of Transportation and Public Works (TPW)'s operational budget which would include the installation and maintenance of rainbow art at four signalized locations to be determined by the Director of TPW; and
- 2. Authorize the Director of TPW to approve requests for rainbow crosswalk art at additional locations only if sufficient funds are provided from an external source and the design is approved by the Traffic Authority.

Members discussed the motion with staff responding to questions.

Staff explained that four (4) rainbow art crosswalks at signalized intersections can be accommodated within Transportation and Public Works (TPW) operating budget, but this does not preclude Council from increasing funding and the number of rainbow art crosswalks in future budgets.

Members spoke to the community's response and support for the program and opportunities to expand the program. Concerns were expressed with paint application and safety, along with its durability and longevity. Suggestions were made on having a more permanent solution, such as incorporating the pigment into the asphalt. Staff explained that rainbow painted crosswalks are not part of the "Red Book"

guidelines but is supported by Transportation and Public Works. Safety was paramount and staff chose a rainbow design centered in the intersection with sections of asphalt separating the colours to reduce friction and risk of slipping. They noted that Council would need to provide direction to alter the design.

Examples were provided where district capital funds could and have been used to install a rainbow painted crosswalk outside of the program funding and how community groups may want to sponsor a crosswalk.

Councillor Smith requested a friendly amendment to include the word *unbudgeted* in the second recommendation, to which Council agreed.

THAT the motion be amended include a request for a staff report to explore an option for safe paint applications and explore design guidelines for future instances.

THAT Halifax Regional Council direct staff to amend By-law P-600 respecting Municipal Parks to add a definition for bicycles as defined in the Nova Scotia Motor Vehicle Act, R.S.N.S 1989.

Members were interested in how By-law P-600 would define the use of motorized bicycles, such as electric assist bicycles (e-bikes) in parks and trails, and addressed concerns with speed. A comment was made on taking into consideration the increased size of mobility scooters and motorized wheelchairs. Staff explained that the adoption of the definition for bicycles will enable the use of electric-assist bicycles of a modest size and power, but will not allow the use of gas-powered bicycles. In response to a question, staff indicated that licensing is not proposed, but in other municipalities stickers are used to identify motorized bicycles, and the Municipality could do this or something similar.

11.2 Case 19535 – Amendments to the Municipal Planning Strategy (MPS) and Land Use By-law (LUB) for Timberlea/Lakeside/Beechville – 1831 St. Margarets Bay Road, Timberlea

The following was before Council:

- A recommendation report submitted by the Chair of Halifax and West Community Council dated July 26, 2017; attached was a staff report dated June 27, 2017
- A draft Extract of Minutes from the Regional Council meeting held on August 15, 2017
- A staff presentation dated September 19, 2017

Sean Gillis, Planner II presented the application of Shining Waters Marine Ltd. to amend the Municipal Planning Strategy (MPS) and Land Use By-law (LUB) for Timberlea/Lakeside/Beechville, to permit commercial development at 1831 St. Margarets Bay Road, Timberlea. The applicant sought to develop a commercial building, which would include a restaurant with a drive thru, general retail and office uses. Gillis advised that if the zoning is changed, the applicant would be able to use the commercial building for any uses permitted under the C-2 Zone.

Gillis responded to questions of clarification, noting:

- Hard surfaces such as paved parking lots create more storm water run off;
- There is no significant public access to the nearby lake; and
- A fence would be required along the property line shared with any residential-zoned properties to provide a buffer.

Mayor Savage invited the applicant to come forward and address Council.

Ross Moore representing Shining Waters Ltd. addressed Council on behalf of the applicant. Moore advised that the proposal represents what Shining Waters intends to achieve, and thanked Council for their consideration.

Mayor Savage reviewed the rules of procedure for public hearings and opened the public hearing for anyone wishing to speak on the matter.

Tristan Costello, Timberlea spoke in support of the application, indicating that the community would be improved by having more businesses in the area. Costello expressed support for increased commercial development that supports a vibrant community.

The Mayor called three times for any other members of the public wishing to speak on the matter. There being none, it was MOVED by Councillor Outhit, seconded by Councillor Karsten

- rezone 1831 St. Margarets Bay Road to the C-2 (General Business) Zone to enable a proposed development with restaurant, retail uses and office uses;
- reduce parking standards for restaurants;
- require new or expanded commercial parking in the C-2 Zone to be visually screened from abutting properties zoned or used for residential or community uses;
- require landscaping in the front yard of new or expanded commercial developments in the C-2 Zone.

Miles Agar, Principal Planner responded to questions regarding the adjacent site owned by the same developer, noting that it would not be affected by the motion on the floor. Agar advised that it is private land, and current zoning would allow for a public park in the future.

11.3 Case 19722 – Amendments to the Halifax Municipal Planning Strategy (MPS) and Halifax Mainland Land Use By-Law (LUB) and Amending Development Agreement for 15 Shoreham Lane, Halifax (Joint Public Hearing with Halifax and West Community Council)

The following was before Council:

- A recommendation report submitted by the Chair of Halifax and West Community Council dated July 26, 2017; attached was a staff report dated June 28, 2017
- A draft Extract of Minutes from the Regional Council meeting held on August 15, 2017
- A staff presentation dated September 19, 2017

Sean Gillis, Planner II presented the application of Gem Health Care Group Limited to allow additional commercial land uses, including a restaurant, in an existing commercial building located at 15 Shoreham Lane, Halifax. The subject property is part of the Melville Heights Residential Development District (RDD) and an existing development agreement is in place. Gillis noted that although the address is on Shoreham Lane, there is significant frontage on Herring Cove Road.

Mayor Savage invited the applicant to come forward and address Council, and the applicant declined.

Mayor Savage reviewed the rules of procedure for public hearings and opened the public hearing for anyone wishing to speak on the matter.

Ross Quackenbush, Armdale noted that the nature of the existing development was as a senior's complex. Quackenbush expressed concern regarding the possibility of a drive thru restaurant, the building's proximity to the property line, and the placement of the mechanical room.

Bruce Holland, Spryfield advised that having attended the public meeting on the matter, it would appear that many of the issues raised have been addressed. Holland advised that a drug store had once been on the site, and that the Spryfield Business Commission supports the application.

The Mayor called three times for any other members of the public wishing to speak on the matter. There being none, it was MOVED by Councillor Outhit, seconded by Councillor Karsten

THAT Regional Council request a staff report on creating an HRM Children's Charter of Rights guided by the belief that "all children deserve basic rights and freedoms and that all levels of government, in partnership with communities, have a duty to support families by putting the health and well-being of children first." The HRM Children's Charter of Rights is to include areas under the municipal mandate as outlined in the MGA and Halifax Charter and should include consideration of:

- 1. The Right to Affordable Housing: enforce minimum standards in dwellings with young children and ensure affordable housing is considered with every new development and/or renovation project
- 2. The Right to Affordable Child Care: consideration of permitting more "home-based" or neighbourhood day care centres in Municipal Planning Strategies and Land Use By-Laws.
- 3. The Right to Access Healthy Food: Encourage more community gardens, Mobile Food Markets.
- 4. The Right to Safety: ensure the Integrated Halifax Regional Police / RCMP continue Community Officers presence in the schools / communities and the School Crossing Guard Program; Traffic: ensure pedestrian infrastructure (sidewalk/crosswalk) is adequate especially in elementary school districts.
- 5. The Right to Safe Potable Water: work with Halifax Regional Water Commission by developing options to assist families in danger of having water services cut.
- 6. The Right to Recreation and Healthy Lifestyle: continue to offer affordable recreation activities for all; consider expanding the Inclusion Program as required; ensure Community Space is included in all developments; Continue Active Transportation and Integrated Mobility Plan and trail development to ensure healthy/active living options for families.

The Chief Administrative Officer, advised that there may be parts of the motion that are outside of municipal control. Staff can provide a report, but it will be a significant amount of work given the breadth and scope of the motion.

A brief discussion ensued with Councillors raising concerns regarding the legal ramifications and the possibility that the motion could provide false hope considering the jurisdictional issues. Members of Council also pointed out that the motion does fit within the Social Development and Healthy, Liveable Communities priorities passed by Regional Council December 2016.

Based on the discussion, Councillor Nicoll suggested the motion be amended to reflect that the staff report would be an information report. The amendment was accepted as friendly.

Mayor Savage clarified that the intent of the motion is to inform the public of capacity that already exists, and does not involve increasing multi-lingual service provision.

- 1. the provision of in-kind financial assistance of a value up to but not exceeding \$500,000, with a net municipal project cost up to but not exceeding \$250,000, to the Parish of St. Paul's for the restoration of a portion of the perimeter ironstone wall and cast iron fencing surrounding St. Paul's Church in accordance with the Heritage Agreement as found at Attachment A, with funding as outlined in the Financial Implications section of the staff report dated August 17, 2017;
- 2. an unbudgeted withdrawal of \$250,000 from the General Contingency Reserve (Q421) to the project budget to fund the net municipal cost of the financial assistance; and
- 3. the expansion of the scope of work, in the 2017-18 fiscal year, as found in the Heritage Agreement as found at Attachment A of the staff report dated August 17, 2017 to allow for the restoration of additional portions of the ironstone wall and cast iron fencing, providing that the net municipal project cost does not exceed \$250,000, and to authorize any necessary amendments to the Heritage Agreement to reflect the expanded scope of work.

- 4. Approve the proposed Heritage Agreement as found at Attachment A of the staff report dated August 17, 2017 with the owner of the municipal heritage property located at 1749 Argyle Street, to restore a portion of the perimeter ironstone wall and cast iron fencing in accordance with the terms contained therein; and
- 5. Authorize the Mayor and Municipal Clerk to execute the Heritage Agreement as found as Attachment A of the staff report dated August 17, 2017 within 120 days, or any extension thereof granted by Council on the request of the applicant, from the date of this approval by Halifax Regional Council and any other bodies as necessary whichever approval is later, including any applicable appeal periods; otherwise this approval will be void and obligations arising hereunder shall be at an end.
- 6. Direct the Chief Administrative Officer (CAO) to direct staff to negotiate, and authorize the CAO to execute, a Contribution Agreement with the Government of Canada for the restoration of a portion of the perimeter ironstone wall and cast iron fencing surrounding St. Paul's Church, for a contribution by HRM not to exceed \$250,000, subject to Regional Council's approval of the provision of financial assistance and the Heritage Agreement as set out in the staff report dated August 17, 2017.
