### **ORIGIN**

September 26, 2019 meeting of the Transportation Standing Committee, Item 15.3.

### **LEGISLATIVE AUTHORITY**

Administrative Order 1, Respecting the Procedures of the Council, Schedule 7, Transportation Standing Committee Terms of Reference, section 4 (c).

### **RECOMMENDATION**

It is recommended that the Budget Committee direct the Chief Administrative Officer to prioritize Integrated Mobility Plan (IMP) related projects as part of the capital budget process considering the principles and considerations outlined in the staff reports presented to the Budget Committee in July and September 2019 and return for approval to the Budget Committee for development of the 2021-2022 budget.

### **BACKGROUND**

At their September 26, 2019 meeting, the Transportation Standing Committee received a Councillor request for consideration form from Councillor Nicoll regarding prioritizing Integrated Mobility Plan related projects in the long-term capital strategy.

## **DISCUSSION**

The Transportation Standing Committee considered the proposed motion set out in the request for consideration form. A friendly amendment was approved that the Standing Committee's recommendation be targeted toward the Budget Committee rather than Halifax Regional Council. The amended motion was approved as outlined in the 'Recommendation' section of this report.

## **FINANCIAL IMPLICATIONS**

The financial implications of the recommendation will be guided by the direction staff has received from the Budget Committee in July and September 2019 in effort to transition to a long-term strategic capital plan. If proposed projects supporting the Integrated Mobility Plan are prioritized to be escalated ahead of annually reoccurring capital programs and high-risk rehabilitation activities, the organization may be at risk for safety and service disruption incidents in addition to higher operating maintenance expenditures for short-term alternatives or emergency repairs.

Alternatively, the Budget Committee could direct staff to increase the capital funding envelope to accommodate an increase to the annual investment. Staff would need to return with funding source options and implications. Consideration would additionally need to be given to whether operations is able to resource the planning, preparation, and delivery of the prioritized IMP projects within the desired timeframe and what the implication may be to other operational goals.

## **RISK CONSIDERATION**

By prioritizing Integrated Mobility Plan related capital projects ahead of annually reoccurring capital programs and high-risk rehabilitation activities, the organization may be at risk for safety and service disruption incidents in addition to higher operating maintenance expenditures for short-term alternatives or emergency repairs.

## **COMMUNITY ENGAGEMENT**

The Transportation Standing Committee meetings are open to public attendance, a live webcast is provided of the meeting, and members of the public are invited to address the Standing Committee for up to five (5) minutes at the end of each meeting during the Public Participation portion of the meeting.
