12.1.1 Devonshire Avenue Pedestrian and Bicycle Improvements

The following was before the Transportation Standing Committee:

THAT the Transportation Standing Committee recommends that Halifax Regional Council approve the installation of 1.3 km of bicycle lanes and related pedestrian improvements as described in the report dated March 21, 2016, on both sides of Devonshire Avenue and on Duffus Street between Novalea Drive and Isleville Street.

Responding to questions of clarification, Mr. Dave Hubley commented that Devonshire Avenue is a daytime truck route and that the traffic on this street is relatively low volume.

Councillor Mason informed the Committee that he had just received an e-mail from Mr. Richard Jenkins in support of the proposed bicycle lane. He informed the Committee of the content of the e-mail and commented that he would circulate the correspondence to the Committee after the meeting.

Councillor Rankin thanked the report authors for a well-written report and commented that there is no reason to continue with this Committee when the remaining elements of the work can be carried out by the Transportation Standing Committee. He noted that there was a general consensus amongst the Crosswalk Safety Advisory Committee members that the staff recommendation is the right approach. He concluded that it is important for crosswalk safety to be formalized as part of the mandate of the Transportation Standing Committee by its inclusion in the Terms of Reference.

Councillor Walker suggested that a letter of congratulations be sent to the members of the Crosswalk Safety Advisory Committee for a job well done.

The Chair indicated that he was in support of the motion and that it was always intended that the work of the Committee would eventually conclude. He remarked that the focus on the important work carried out by this Committee will not be lost.
