## 10.3.1 John Hawkins and Derek Estabrook of Heritage Gas re: Natural Gas Initiatives and Supply & Pricing Update

The following was before the Environment and Sustainability Standing Committee:

A presentation dated May 12, 2016

Mr. John Hawkins and Mr. Derek Estabrook of Heritage Gas provided a presentation. Highlights include:

- Natural gas helps achieve greenhouse gas emissions targets in the Community Energy Plan;
- Forthcoming reduction in the Base Energy Charge for RC1 commercial customers, pending a final hearing with the Nova Scotia Utility and Review Board;
- Commentary with respect to natural gas supply and pricing;
- Opportunities for cooperation between Heritage Gas and HRM including using natural gas as a 'bridge fuel' to renewable energy and expanding the natural gas system in HRM through revisions to the Subdivision By-law.

Mr. Hawkins and Mr. Estabrook responded to questions of clarification, noting the following:

• It is difficult to calculate the payback period for conversion to natural gas, as the rate of return is a function of how much you save from your current choice, and the price of oil has been fluctuating. Historically, the payback period has been roughly five to ten years.

• The current marketing focus is on the approximately 9000 residential customers who are on a gas main but have not yet converted to natural gas. In the long term, Heritage Gas is looking to expand pipeline mains in urban areas where density makes it economically viable.

The Chair thanked the presenters for providing information for the Committee's consideration.
