10.3.1 Michael Karanicolas and Paul Conrod of Right to Know Coalition of Nova Scotia re: Transparency in the Halifax Regional Municipality

The following was before the Executive Standing Committee:

- A memorandum from the Procurement Manager dated March 7, 2016 re: Response to Study Regarding Transparency in HRM
- A copy of the report issued by Right to Know Coalition of Nova Scotia entitled "Transparency in HRM: Room for Improvement"

Mr. Michael Karanicolas and Mr. Paul Conrod delivered a presentation to the Standing Committee regarding Transparency in the Halifax Regional Municipality (HRM). Key highlights include:

- Benefits of robust transparency systems include improving governance, combating waste and corruption, improving citizen engagement and promoting commercial development.
- The business community are among the most active consumers of public information.
- Although the municipality is already exceeding the minimum legal requirements regarding sharing information related to contracts and tenders above \$25,000, The Right to Know Coalition of Nova Scotia (RTK) recommends that HRM provide this data to the public more proactively, in user-friendly formats, and share details through an annual report.

- RTK recommends that statistics regarding in camera (in private) meetings be regularly released to the public and that these meetings be recorded so that they may be made available once the matter is no longer sensitive.
- HRM should reach out to stakeholders to consider ways to improve the procurement process.

Councillor Mosher joined the meeting at 10:16 a.m.

Mayor Savage thanked the presenters for their information. He noted that the municipality is working to collect and release statistics including the number and duration of in camera (in private) meetings.

A brief discussion ensued. Responding to a question regarding whether there would be a review of Administrative Order 35, the Halifax Regional Municipality Procurement Administrative Order, Mr. John Traves, Chief Administrative Officer indicated that the review has already been initiated. Mr. Traves advised that the matter will be brought before Council to seek input and direction.
