Mr. Scott Guthrie of the Crosswalk Safety Society of Nova Scotia provided a hand-out to Standing Committee members outlining the material of the presentation. Referring to the hand-out, Mr. Guthrie emphasized that the crosswalk flags are not only beneficial when they are used by pedestrians to cross the street, but that they also increase visibility of the crosswalk itself and, as staff have indicated, 87% of drivers yield to the crosswalks that have crosswalk flags. Mr. Guthrie indicated that the Crosswalk Safety Society would like that crosswalk flags be allowed to be installed as they currently are and continue to be managed by the society.

16.1 Councillor Russell Walker

Take notice at the next meeting of the Transportation Standing Committee to be held on July 21, 2016 I will ask for a staff report on the use of Lone Light (RRFB) Rapid Flashing Beacons for crosswalks in HRM.

17. PUBLIC PARTICIPATION

Mr. Jerry Blumenthal of Halifax indicated that he was speaking on behalf of the Canadian Association of Retired Persons (CARP). He explained that in January, the Province passed a bill allowing Segways on the sidewalks, but that no accessibility groups were consulted. He noted that he is not against Segway tours in which there are guides in the front and the back of the group, but that he is concerned about private citizens purchasing the devices and using them on the sidewalks of HRM. He questioned why Segways would be allowed on the sidewalks if bikes are not. Mr. Blumenthal noted that there are many people in the North End of Halifax with vision and hearing impairments, in addition to many seniors. He commented that Segways will make the sidewalks unsafe for these residents and requested that HRM conduct thorough research as to the safety concerns regarding Segways on the sidewalks. He noted that it is the prerogative of municipalities to create by-laws regarding Segways and that he hopes HRM will do so.

Mr. Max Rastelli commented that he respects everyone's opinion on the matter of Segways and that there was a two-year pilot project regarding Segway regulations in which the public was consulted. He explained that the data complied indicates that Segways are safe on sidewalks. He noted that it is not fair to compare Segways to bicycles as they are much more maneuverable. He noted that there are already strict regulations and speed limits in place regarding Segway use in Nova Scotia.

Councillor Mason questioned the safety concerns regarding silently running vehicles and questioned whether it is appropriate to have Segways on congested streets such as Spring Garden Road.

Responding to a question from Councillor Mason, Mr. Max Rastelli informed the Standing Committee that Segway riders are required to have a horn or a bell. He stated that, as a Segway tour operator, he avoids congested areas. He noted that Segways do well in crowded spaces and that his first experience with Segways was in Rome, which is much busier than Halifax.

Ms. Milena Khazanavicius of Halifax commented that she has nothing to say against Mr. Max Rastelli or his business, but that Segways do not belong on the sidewalks in HRM. Guide dogs are trained to avoid traffic and vehicles, and having Segways on the sidewalks would make it difficult for them to do their job. She explained that while public consultation was conducted regarding Segways, it was not conducted in all of Nova Scotia and did not engage accessibility groups or people with a disability. Ms. Khazanavicius submitted two pieces of correspondence for the public record from members of the public who were unable to attend the meeting and who wished that the letters would be read on their behalf. The pieces of correspondence were from Ms. Janet Brush and Ms. Johanna Stork.

Ms. Pat Gates of Halifax commented that she has multiple disabilities and is very active. She explained that she frequently uses the Access a Bus and is often in locations waiting for the bus such as the new Central Library and that she would not hear the hum of a Segway to know if one was approaching. Ms. Gates expressed her hope that HRM would thoroughly research the safety of having Segways on the sidewalk in HRM. She commented that she does not have an issue with Segways in general and she believes healthy communities are for everyone, including people with disabilities and seniors

Mr. Barry Abbot of North End Halifax thanked the Standing Committee for the opportunity to speak. He commented that he has no issue with Segways in parks and trails that are wide enough to accommodate them, but that the sidewalks in Halifax are too narrow to safely accommodate Segways.
