10.3 Presentation

10.3.1 Halifax Idle-Free Climate Action – Ron Zima, GoGreen Communications & The Children's Clean Air Network and Bill VanGorder, Canadian Association of Retired Persons

The following information was before the Committee:

Ron Zima, CEO, GoGreen Communications Inc., and Bill VanGorder, member of Canadian Association of Retired Persons, presented a proposed Idle-Free Climate Action Plan to the Committee. The presentation with a link to the video shown during the presentation are available online; the presentation is also on file.

Ron Zima and Bruce McCulloch responded to questions from the Committee.

At the request of the Committee, Rob Zima reviewed the E3 Fleet review, which would be a comprehensive review of technologies available, analyze data from the current fleet, measure fuel/CO2 savings, and certify results. A sampling of E3 Fleet membership across Canada and E3 Peer Benchmarking example.

Councillor Karsten thanked the presenters, and noted that this presentation was also provided to the Transportation Standing Committee on March 23, 2017, at which time the presentation was referred for a staff report.

- While the Halifax Waste Resource Society is not a recognized stakeholder in the process, they would be happy to participate and support an extended producer responsibility initiative by HRM.
- Styrofoam recycling will only be addressed through extended producer responsibility.

John Cascadden spoke in support of HRM pressing forward and taking a leadership role on this matter.
