10.3 Presentation

10.3.1 Aimee Gasparetto, Senior Coordinator, Community Food, Ecology Action Centre – Halifax Food Policy Alliance

The following was before the committee:

- A presentation dated April 20, 2017
- A report from the Halifax Food Policy Alliance dated 2014, entitled: Food Counts Halifax Food Policy Assessment.

Aimee Gasparatto, Senior Coordinator, Community Food, Ecology Action Centre and Ali Shaver, Healthy Built Environment Coordinator, Nova Scotia Health Authority provided a presentation on the Halifax Food Policy Alliance.

In response to questions from the committee, Aimee Gasparetto and Ali Shaver noted the following:

- A charter and strategy regarding food security is an ideal path forward for HRM as many other municipalities in Canada have adopted similar policies with success.
- The Halifax Food Policy Alliance includes members from Feed Nova Scotia, The Nova Scotia Health Authority, Dalhousie University, the Ecology Action Centre, the Seaport Farmers Market, the Nova Scotia Federation of Agriculture, and the Dartmouth North Community Food Centre.
- The Halifax Regional Municipality can continue to support the work of the Halifax Food Policy Alliance by encouraging further collaboration among interested groups, continuing policy work in the area of food security, investing in recreation centres and community spaces, and engaging in future work to create a Food Charter and Food Strategy for HRM

In response to a question of clarification, Leticia Smillie, Planner III noted involvement as the HRM liaison with the Halifax Food Policy Alliance. Smillie commented that any further involvement on the part of the municipality would be effectively managed to ensure the appropriate departments are fully engaged.

Councillor Mason thanked Aimee Gasparetto and Ali Shaver for their presentation.

10.3.2 Patrick Stubbert - HRM Off-leash Dog Park Strategy

The following was before the committee:

• A handout from Patrick Stubbert re: Sunrise Beach – Shubie Park

Patrick Stubbert of Dartmouth provided a presentation with respect to HRM's Off-Lease Dog Park Strategy. Stubbert provided background information, specifically in relation to Sunrise Beach-Shubie Park which abuts residential properties in Dartmouth. Stubbert raised concerns from neighbours and through personal experience as an affected homeowner, about dogs wondering on to nearby residential properties, noise complaints from barking, and the preponderance of dog excrement which litters residential properties and the beach.

Stubbert questioned whether or not the proposal for the off-leash section of Shubie Park was ever approved by Council citing personal research which did not reveal evidence of approval. Stubbert noted that the off-leash section of the park was a pilot project which has not yet ended. Stubbert concluded by articulating how neighbours in the area have been negatively impacted by the dog park and requested that the committee explore options to address and mitigate the issue such as relocating the off-leash area to a different section of the park, or to return Sunrise Beach and the area adjacent to homes as an on-leash area.

In response to questions of clarification, Brad Anguish, Director of Parks and Recreation commented that staff does not plan on moving the off-leash dog park at Shubie Park because it has not received direction from Council to do so. Anguish further noted that a staff report regarding an Off-leash Administrative Order is anticipated in the near future which will provide clarity with respect to policy implementation and off-leash pilot projects.
