10.3.1 J.B. Kent Smith, President, Musquodoboit Harbour and Area Chamber of Commerce and Civic Affairs - Community Development Plan

The following documentation was before the Standing Committee:

 A report from Ekistics Plan and Design re: Musquodoboit Harbour Chamber of Commerce & Civic Affairs

Councillor Outhit joined the meeting at 10:08 a.m.

J.B. Kent Smith, President of the Musquodoboit Harbour and Area Chamber of Commerce & Civic Affairs (MHACCCA), provided a presentation with respect to the Community Development Plan.

Councillor Mason thanked J. B. Kent Smith for the presentation and requested questions of clarification from members of the Community Planning & Economic Development Standing Committee.

In response to questions of clarification, Smith noted the following:

- The next steps for the Musquodoboit Harbour and Area Chamber of Commerce and Civic Affairs will be to develop its newly formed Standing Committees and their respective Terms of Reference and Guidelines.
- The MHACCA does not expect the required \$30 to \$40 million in funding from other levels of government to provide a central water system for the area. The newly formed Infrastructure and Planning Standing Committee will be tasked with exploring options to ensure potable water is available in the downtown area as well as addressing wastewater concerns at the Sheet Harbour Hospital.

10.3.2 Sherry Donovan, CEO Canadian Home Builders' Association Nova Scotia – Pilot program for Licensing Contractors/Deed Transfer Taxes

Sherry Donovan, CEO of the Canadian Home Builders' Association Nova Scotia, (CHBANS) introduced Andrew Holley, former President and CEO and provided a presentation with respect to a Pilot Program for Licensing Contractors/Deed Transfer Taxes.

Councillor Mason thanked Sherry Donovan and Andrew Holley for their presentation and requested questions of clarification from members of the Community Planning & Economic Development Standing Committee.

In response to questions of clarification, Donovan and Holley noted the following:

- The CHBANS views the Deed Transfer Tax as financial burden to homebuyers that creates a barrier to homeownership particularly among new homebuyers.
- The CHBANS suggests that the Deed Transfer tax be re-visited to allow for options for homebuyers in terms of how it is paid. This could mean waiving the Deed Transfer Tax for new home buyers or allowing it to be paid over a five-year period.
- The CHBANS would like to partner with the municipality to finalize the development of a licensing program for contractors as a consumer and industry protection measure.
- CHBANS has been working with national members and industry to compile figures with respect to
 the amount of "Under the Table" work being undertaken by unlicensed contractors in the
 Canadian Economy. The agency estimates that conservatively, one-third of home renovations are
 being conducted by unlicensed and uncertified contractors.
- There has been a great deal of support from industry for a licensing program as many consumer complaints are centred on the issue of poor workmanship.

- **16.1 Councillor Mason**
- "TAKE NOTICE, that at the next regular meeting of the Community Planning & Economic Development Standing Committee, I intend to introduce a motion that the Community Planning & Economic Development Standing Committee request a staff report regarding options and financial implications to enhanced support for protection of heritage buildings in HRM, that shall include consultation with the Heritage Advisory Committee as appropriate, and include but not be limited to the following considerations:
- 1. Tax relief That registered heritage properties could receive an annual grant calculated as a percentage of property taxes paid;
- 2. Tax lift Upon approval of a major renovation and or restoration project any increase in property taxes that result from the resulting increased assessment would be rebated as a grant for a period of time, for example, 10 years;
- 3. Grants that the existing grants program would be expanded to allow for increased financial support for residential buildings, a separate program for commercial buildings, and inclusion of privately held institutional buildings in the grant program;
- 4. 20th Century heritage consider changing heritage registration criteria to better encourage registration of outstanding architectural examples from the war years (1918-1945) and create a mid-century category from 1945-1975;
- 5. Holding bylaw request the province allow municipalities to establish a heritage holding bylaw similar to other provinces, to allow short term protection of important unregistered historic buildings while Council considers possible registration".
