### 8.1 Carriage of Two-Wheeled Devices of Halifax Transit Ferries

THAT the Transportation Standing Committee recommend that Halifax Regional Council direct staff to modify Halifax Transit Ferries and introduce rules to govern the carriage of two wheeled devices on ferries as outlined in the staff report dated April 10, 2017.

Councillor Nicoll moved the following amendment:

## THAT the Transportation Standing Committee recommend that Halifax Regional

Council:

Approve modifications to the Halifax Transit ferries to accommodate an additional bicycle rack;
Restrict the number of standard sized bicycles carried per crossing to the number that can be accommodated in bicycle racks;

3. Approve the installation of tire sizing racks at the ferry terminals to ensure that bicycles can be accommodated prior to boarding; and

4. Prohibit segways from the Halifax Transit ferries.

3. Approve the installation of tire sizing racks at the ferry terminals to ensure that bicycles can be accommodated prior to boarding; and

4. Prohibit segways from the Halifax Transit ferries.

In response to questions of clarification, Patricia Hughes, Manager of Scheduling, Halifax Transit clarified that the ferry load counts were conducted on a typical weekday.

Dave Reage, Director, Halifax Transit advised that a further reduction in the number of seating on Halifax Transit Ferry's would likely need to take place to accommodate other types of personal transportation devices such as segways.

## 12.1.2 Pedestrian Connection, St. Margaret's Bay

THAT the Transportation Standing Committee recommends that Halifax Regional Council direct staff to continue planning pedestrian connections from St. Margaret's Bay Elementary to the St. Margaret's Bay Rails to Trails and the HRM ball field, playground and Bay waterfront access as identified in the Discussion section of the staff report dated September 11, 2017, and report back to the Transportation Standing Committee with a proposed pedestrian connection.

In response to concern raised by the Transportation Standing Committee, Dave MacIsaac, Active Transportation Supervisor noted the following:

- The St. Margaret's Bay pedestrian project is currently in the preliminary stages of the planning process and is relevant to HRM's Active Transportation priorities particularly by improving connectivity in a rural area.
- Halifax Regional Police review potential Active Transportation trails from a safety perspective as part of the planning process.
- Staff undertake community consultations with area residence and effected landowners through a general mail call and advertising through conventional, and social media.
