12. REPORTS

12.1 STAFF

12.1.1 Recycling Market Conditions – Information Report and Staff Presentation – *Matt Keliher, Manager, Solid Waste Resources*

The following was before the Committee:

- Information Report dated October 12, 2017, titled: "Recycling Market Conditions";
- Presentation titled "Recycling Market Conditions."

Matt Keliher provided the committee with a presentation on the topic of recycling and current market conditions in Halifax. The presentation focused on the recent decision of the Chinese Government to close its borders to imports of raw recycling materials, and the particular consequences of this decision on the HRM and its waste management program.

With the ban on exporting recycling materials to China coming with little notice, HRM Solid Waste Management has struggled to find a solution regarding how to deal with these materials in the interim period until a long-term solution can be developed. Matt Keliher noted that film plastic waste is a particular issue, due to current restrictive Provincial regulations and a lack of current capacity to process these materials.

As a consequence of these developments, film plastics are being stored on site by HRM Solid Waste Management, and there appears to be no market for these materials at the present time. Petitions have been made to the Province to allow for a special dispensation of these on-site materials, however, the HRM has received no response to date.

Matt Keliher concluded his presentation stating that an important point arising from the Chinese recycling import ban is that recyclers across North America need to become less dependant on foreign entities to recycle their materials and that the capacity to process these materials within the Province needs to be developed.

Responding to questions from the Committee concerning the scope of the current problem, as well as potential paths forward, Matt Keliher suggested that the implementation of greater Extended Producer Responsibility ("EPR") may be the best strategy to assist in reducing the burden of waste materials handled in HRM. However, he further pointed out that it is the Province who would have to take the lead on expanding the implementation of EPR for it to be effective. Members of the Committee pointed out that Regional Council has already expressed its full support of EPR.

With regards to options for addressing the immediate problem of storing these film plastics, Matt Keliher indicated that Solid Waste Resources is currently investigating different options. However, he noted that simply storing these materials in the interim period would result in additional costs for materials which will most likely end up in a Landfill.

The Chair thanked Matt Keliher for his presentation.

12.1.2 Options to Reduce or Eliminate the use of Plastic Shopping Bags in the Municipality

The following was before the Committee:

MOVED by Councillor Mancini, seconded by Councillor Karsten

THAT the Environment and Sustainability Standing Committee recommend that Halifax Regional Council direct the CAO to ensure staff engages with appropriate Nova Scotia Environment staff and members of the Solid Waste-Resource Management Regional Chairs Committee ('Regional Chairs') to discuss options for a unified approach to reduce or eliminate the use of plastic shopping bags in all Nova Scotia municipalities, particularly in light of the changing plastic film commodity markets worldwide.

At the request of the Committee, Shannon Miedema, Manager of Energy & Environment HRM, and Alex MacDonald, Environmental Performance Officer and Climate Change Specialist with Energy & Environment HRM, outlined some examples of how other jurisdictions have approached dealing with the issue of plastic shopping bags.

The following amendment was proposed by Councillor Karsten:

THAT the motion be amended to include the wording: "including, but not limited to, Extended Producer Responsibility ("EPR")" immediately following the words "to discuss options."

The amendment was considered by the Committee as friendly.

Councillor Cleary noted that the report indicates that the Municipality does not have explicit authority to levy a fee on plastic bags. However, he inquired as to whether this would likewise prohibit the Municipality from implementing a deposit on plastic bags. In response, Alex MacDonald stated that while this is a question which would need to be referred to legal services for a more authoritative answer, from his understanding, it is a possibility that the Municipality might be able to look into. Councillor Hendsbee expressed concern about the Municipality's capacity and jurisdiction to be able to administer and enforce such a deposit.

MOVED by Councillor Mancini, seconded by Councillor Cleary that the motion be amended to add the following alternative:

THAT staff collaborate to engage with retailers and external experts on options to eliminate or reduce use of plastic shopping bags in the Municipality, and return at a future date with a recommended option.

MOTION TO AMEND PUT AND PASSED.

The amended motion was voted on at this time, as follows:

THAT the Environment and Sustainability Standing Committee recommend that Halifax Regional Council:

- direct the CAO to ensure staff engages with appropriate Nova Scotia Environment staff and members of the Solid Waste-Resource Management Regional Chairs Committee ('Regional Chairs') to discuss options including but not limited to Extended Producer Responsibility (EPR) for a unified approach to reduce or eliminate the use of plastic shopping bags in all Nova Scotia municipalities, particularly in light of the changing plastic film commodity markets worldwide; and
- 2. That staff collaborate to engage with retailers and external experts on options to eliminate or reduce use of plastic shopping bags in the Municipality, and return at a future date with a recommended option.

- 3. Land Development Practices
- 4. Drainage on Private Property
- 5. Wetlands
- 6. Combined Sewers
- 7. Flood Resilient Design Standards

Peter Duncan, Manager of HRM Infrastructure & Planning Office, and Shannon O'Connell, Development Engineer with HRM Infrastructure & Planning Office, as well as Jamie Hannam of Halifax Water, presented to the Committee on the topic of the HRM's strategy for integrated stormwater management. The presentation touched upon funding for natural disaster mitigation programs, and the multi-agency responsibilities for stormwater management, the policy objectives of HRM Infrastructure Planning and Halifax Water for stormwater management, as well as their capital investment strategy.

Councillor Smith joined the Committee at 11:41 a.m.

Councillor Blackburn inquired as to whether the current co-mingling of stormwater and wastewater presents a significant problem for the management of stormwater infrastructure in the HRM. Responding to the question, Jamie Hannam indicated that at present it is a significant issue. However, Halifax Water and HRM are committing significant resources in terms of capital and operational investment to address the issue.
