# 10.3.1 Jayme Melrose, Common Roots Urban Farm – Support for new location for the Common Roots Urban Farm

The following was before the Standing Committee:

• A presentation entitled "Common Routes Urban Farm: The Big Move"

Jayme Melrose of Common Roots Urban Farm provided a presentation respecting HRM support for a new location for the Common Routes Urban Farm. Highlights of the presentation included:

- An overview of Common Routes Urban Farm; its community based operations; and its planned relocation in 2019.
- Current initiatives respecting the move of the farm from its current location on QE II Health Science Centre lands.
- Potential sites for the relocation of the farm and the desire for it to be located on the peninsula near accessible transportation options.
- Requests for HRM support in establishing a new headquarters for the farm; facilitating the relocation of the farm's Community Garden Plots; and logistical support with the move in April 2019.

In response to questions from Standing Committee, Melrose advised that there have not been formal discussions with the province to relocate the farm on provincial land, but it is an option that is being

explored. Melrose further advised of Common Routes Urban Farm's interest in the potential for its operations to take place on lands within the Halifax Common, or nearby.

Denise Schofield, Director of Parks and Recreation advised that the consideration of any additional uses on the Commons Lands should take place after the Halifax Common's Master Plan is complete. Schofield provided further commentary with respect to potential logistical support that HRM could provide in assisting with a move.

MOVED by Councillor Smith, seconded by Councillor Mason

THAT the Community Planning and Economic Development Standing Committee request a staff report to explore the following:

- 1. Potential support from HRM to secure a new headquarters for Common Roots Urban Farms.
- 2. Potential support from HRM to facilitate the relocation of Common Roots Urban Farm's Community Garden plots; and
- 3. Potential support from HRM to assist Common Roots Urban Farm with its move in April 2019.
