Peter Zimmer, Halifax spoke to the 2024 Road Safety Annual Report. Zimmer commented on Regional Council supporting Vision Zero and the Integrated Mobility Plan, and suggested the reduction of speed limits, the use of automated enforcement, and encouraged the Municipality to be a leader and to advocate to the Province. Zimmer responded to questions of clarification from the Standing Committee.

Howard Epstein, Halifax spoke to the Robie Street transportation corridor between North Street to Chebucto Road and provided a handout that outlined their recommendations.

Peggy Cameron, **Halifax** provided a handout and expressed concern with the Municipality's plan to widen Robie Street.

Norm Collins, Halifax spoke to the 2024 Road Safety Annual Report, highlighting their comments outlined in their correspondence provided for item 13.1.2.

Matt Stickland, District 2 spoke to the Proposed Residential Parking Permit Surcharge for Long Vehicles report. Stickland expressed concern that the fiscal responsibility assessment was not being implemented by the Municipality's business units.
