#### 12. REPORTS 12.1 STAFF 12.1.1 Proposed Route 91 – Hemlock Ravine

THAT the Transportation Standing Committee recommend that Halifax Regional Council direct the Chief Administrative Officer to monitor operations along Oceanview Drive following the implementation of Route 91 – Hemlock Ravine to identify any adjustments to bus stop locations, on-street parking and/or the installation of additional pavement markings, signage or other infrastructure, as required, resulting from the implementation of the transit route.

Responding to questions from members of the Standing Committee, Taso Koutroulakis, Manager of Traffic Management, noted that collector streets qualify for traffic calming measures. They added that based on current resource restrains, it would be unlikely that Oceanview would undergo a traffic calming assessment in the next year or more. With regards to parking restrictions, it was noted that municipal staff and police are on the site regularly, and under the recommendation before the Standing Committee, no-parking signs would be installed by the school zones. Responding to further questions, Koutroulakis noted that most of the traffic along the route is generated from the neighbourhood and would not be considered 'short-cutting'.

THAT the Transportation Standing Committee request a staff report that assess the potential benefits to vulnerable road users of restricting right turns by all or various vehicles on red lights at either all intersections or intersection at and/or near areas of pedestrian concentration including, but not limited to, pedestrian-oriented mainstreets, schools, community and recreation centres, libraries, parks, and other significant public spaces.

Councillor Cleary spoke to the motion, noting that approximately 20% of accidents with vulnerable road users result from right-turn movements. They requested that staff be directed to examine the potential benefits of restricting right turns on red lights as a means of reducing collisions.

Speaking to the motion, Councillor Austin clarified that while Integrated Mobility Plan related projects came before the Budget Committee when they initially considered the capital budget process in July and September 2019, the motion before the Standing Committee would be asking Council to prioritize those projects.

John Traves, Municipal Solicitor, suggested that the motion be amended so as to direct the Standing Committee's recommendation to the Budget Committee, rather than Halifax Regional Council, as the Budget Committee deals with more of the details in developing the capital budget. Councillor Austin agreed with the suggestion and put forward the following amendment.

THAT the motion be amended from "...the Transportation Standing Committee recommend that Regional Council direct the Chief Administrative Officer..." To "...the Transportation Standing Committee recommend that the Budget Committee direct the Chief Administrative Officer...".

The amended was considered friendly by the Standing Committee.

### **17. PUBLIC PARTICIPATION**

This item was moved forward on the agenda during the setting of the Order of Business to take place prior to Item 12 Reports.

The Chair called for any members of the public wishing to speak to the Standing Committee to come forward.

**Josh Hagle**, Bedford, expressed their concerns to the Standing Committee regarding the proposed route 91 to Hemlock Ravine. They noted that no development has occurred in the Paper Mill Lake subdivision since 2001, yet the area has experienced significant traffic issues. They noted that the main cause of this is a failed development agreement in the area under which Nine Mile Drive would have been developed into a collector street connecting to Moirs Mill Road and Oceanview Drive. This did not occur, and as a result, Nine Mile Drive and Moirs Mill Road are dead end streets, which has severely impacted the traffic flow in the area. They added that in 2014, Nine Mile Drive was connected to Larry Uteck Boulevard via Oceanview Drive, which has increased the flow of traffic beyond what was intended for these streets. They expressed their opposition to the proposal to add a transit route on Oceanview Drive when it is already operating over its design capacity. They cited several Municipal traffic assessments to support the notion that the traffic on Oceanview Drive exceeds its design capacity.

The Chair called three (3) times for any further members of the public wishing to speak to the Standing Committee to come forward; there were none.
