**12.1.1 2020/21 First Quarter Halifax Transit Key Performance Indicator Report**

The following was before the Standing Committee:

Patricia Hughes, Manager of Planning & Customer Engagement, provided the Standing Committee with a presentation on 2020/21 First Quarter Halifax Transit Key Performance Indicators.

Responding to questions from members of the Standing Committee, Patricia Hughes noted that current ridership indicators show that ridership during weekends is roughly similar to pre-pandemic levels, however weekday service is currently about 55 to 57%. Staff had been aiming for 60% and will continue to do so. Details regarding next steps for the West Bedford transit project and park and rides are on track to receive an update shortly and construction work is anticipated to begin in April and conclude before the end of the 2021 construction season.

Marc Santilli, Manager of Technical Services responded to questions related to transit delays and the service improvement plan.

Several Councillors discussed concerns regarding mask policies for transit and raised concerns from residents regarding persons using transit while not wearing masks. Dave Reage, Director of Halifax Transit, noted that voluntary compliance has been quite high and very few transit users have declined to

wear masks while using transit. Regarding enforcement, Dave Reage stated that Halifax Transit continues to follow Provincial guidelines and direction from Dr. Strang which at this time emphasize education and informing transit users of mask policies.

- 1. Adopt By-law U-107, the purpose of which is to amend Schedule 1 of By-law U-100, the User Charges By-law, establishing a permanent fare change for children twelve years of age and under, and adopting several housekeeping changes, as set out in Attachment E of the staff report dated August 10, 2020; and**
- 2. Direct staff to prepare a staff report considering the potential for discounting bulk purchases of single transit fares (ie tickets) for both non-profit agencies, and promotional events.**

Some Councillors raised concerns regarding the timing of the motion in the context of anticipated continuing lost income for transit due to the Covid-19 pandemic. Dave Reage, Director of Halifax Transit, stated that staff recognizes that while there will be challenges associated with rebuilding transit ridership following the pandemic, staff sees this as an investment in the future.

**13.1 Councillor Cleary – Criteria for New Marked Crosswalks**

MOVED by Councillor Russell, seconded by Deputy Mayor Outhit

**THAT the Transportation Standing Committee request a staff report to review and establish criteria for new marked crosswalks that shall account for:**

- 1. not just existing crossings but also projected crossing demand;**
- 2. that takes into account land uses, present and future demand;**
- 3. pedestrian compliance, speed, safety, and crash history;**
- 4. recognizes that the practice of discouraging pedestrian crossings by leaving uncontrolled crossings unmarked is not a valid safety measure; and**

**5. prioritizes proximity to schools, school walking routes, parks, trails, and other active transportation facilities as critical pedestrian destinations.**

Several Councillors expressed a desire that the report also address options for crosswalk criteria relating to crosswalk prioritization in school zones. Other Councillors raised a desire to address options for crosswalk criteria relating to crosswalk prioritization relating to tourism destinations and localized destinations that go beyond transportation elements. Another Councillor raised a desire to address opportunities to examine options for crosswalk prioritization in several locations including on Washmill Lake Drive and Langbrae Drive. Taso Koutroulakis, Manager of Traffic Management, stated that staff anticipates that as part of the upcoming capital plan staff will return to Regional Council with a plan to install an overhead lights intersection on Washmill Lake Drive, and staff proposed to have a further discussion with the Councillor regarding opportunities for crosswalks on Langbrae Drive.
