Summary

- 13 vehicle/pedestrian/bicycle collisions were reported in January 2020, in Halifax Regional Municipality.
- Of these collisions, 0 involved a bicycle/scooter/skateboard.
- The remaining 13 incidents were strictly vehicle/pedestrian collisions, with 13 pedestrian victims.




Trends

Vehicle/pedestrian collisions saw a decrease in January 2020 over the previous month. It should be noted, however, that the number of incidents decreased by 6 when compared to January of 2019.



Trends

When comparing incidents in January 2016 - 2020, noted incidents have decreased by 32% in 2020 compared to the previous year.

When comparing January 2020 to the same time period in 2019, decreases were observed in all three Divisions.

HRM


There have been 6 less collisions or a 32% decrease of reported incidents in 2020 compared to the same time period in 2019.







Collision Types

A higher percentage of vehicle/pedestrian collisions took place in crosswalks in January 2020 when compared to January 2019.

Injuries

8 or 62% of the 13 pedestrian victims experienced either no injury or minor injury in January of 2020.


There has been 0 pedestrian fatalities thus far in HRM in 2020.


Pedestrian Characteristics

Males accounted for 6 or 60% of drivers involved in vehicle pedestrian collisions in 2020.




Peak Collision Times

In January 2020, peak time for collisions was 7 am and 2pm, while peak day for collisions was Tuesday.

Weather & Lighting Conditions

7 or 54% of the reported motor vehicle pedestrian collisions in January 2020 occurred during clear and/or sunny weather conditions.

There were 5 collisions which took place during overcast or rain and/or foggy conditions.

7 or 54% of the reported collisions took place during daylight.

3 or 23% of the reported collisions took place during daylight with clear and/or sunny weather conditions.
