## BEAZLEY FIELD #1 DIAMOND – 2017 Season CLIENT CHECK LIST FOR BALL DIAMOND USE

### Infield Grooming:

- ❖ Hand Tools Only (i.e. Rakes, Shovels, Tampers)
- ❖ **No removing of infield material** or 'channelling' of water
- ❖ **No removal of clay** from the pitcher's mound
- ❖ No sawdust
- ❖ No gasoline/fire
- ❖ No licensed/private vehicles permitted on infields for dragging purposes;  
Only 'ATV' type vehicles or smaller, **with permission requested and received prior to use**
- ❖ **TARPS** - It is the responsibility of the clients using the field to ensure tarps are put in place prior to leaving the site at the end of a game (Diamond #1)
- ❖ Ensure bases are removed from the field and stored away after use (Diamond #1)

### Use of Clay and Absorbent:

- ❖ Product will be made available and left on site for clients to use, when required. Please keep in mind that this material is costly and use appropriately. 1 key will need to be signed out (\$25.00 deposit required) to access this box.

### Water Box/Hose:

Access to the Water Box and Use of the Hose (s) requires special permission. Groups that need access to water the infield need to appoint a representative that will accept the responsibility of:

1. Signing out a key (\$25.00 deposit required).
2. Rolling up the hoses and storing them back in the box as they were found (kinking of the hoses causes breakage).
3. Locking up the box and ensuring that it is secured after use.

**Failure to comply with the above will result in your group being fined and the loss of access to the watering system.**

### Field Lights:

- ❖ No access to electrical panel(s)
- ❖ No changing of light timers
- ❖ Ensure lights are turned off prior to leaving the facility (key switch is turned to the 'off' position)

### In General:

- ❖ Clients are to **be mindful of their time allotments** for field use and **schedule accordingly**
- ❖ Clients are to **be respectful** to each other while using the facility
- ❖ Clients must ensure the site, including the Field House/Press Box is **cleaned up of all litter**, etc. after use (including 'Home' and 'Visitor' dugouts)
- ❖ Clients must **adhere to the Field Condition Line**
- ❖ Clients must keep the **volume of the sound system to a respectable level**
- ❖ Clients must be mindful of the **quality of music** being broadcast.
- ❖ Clients must ensure that all **Field House doors and Gates are locked** prior to leaving the site
- ❖ **Use 3-1-1** and/or [contacthrm@halifax.ca](mailto:contacthrm@halifax.ca) to contact the municipal Corporate Call Centre to report any field related concerns
- ❖ **BBQ Propane Tanks** are not to be stored inside the Field House.
- ❖ Use of the **Canteen and the Electrical Room for storage is not permitted** due to Fire Regulations. Offending groups will be fined and access to these spaces will be denied.
- ❖ **Smoking, including e-cigarettes/vaping, is not permitted** in, on or around any municipal facility (i.e. field house/washroom, park, plaza, diamond, sport field, etc.) per <http://www.halifax.ca/rec/policies.php#Smokefreespaces> and the Smoke Free Places Act (Bill 125)
