- the funds are to be used **only** for the purchase of insurance by the community group for the rink
- the community group will be required to submit the receipt showing proof of payment and the amount paid
- any funds not spent by the community group for the rink insurance **must** be returned to the municipality

NOTE: Failure to comply with the conditions of the grant may result in ineligibility for any such grant in the following year.
